Brooklyn Village Board Meeting Minutes August 22, 2016

The August 22, 2016 Village Board meeting of the Village of Brooklyn was called to order at 6:36 pm at the Village Hall by President Pat Hawkey. Trustees present were Kyle Smith, Todd Klahn, Bruce Crubaugh. Heather Kirkpatrick arrived at 6:37 pm. Russ Cazier arrived during closed session at 7:44 pm. Trustees absent Sue McCallum. Others present Cindy Jazdzewski, Chief Barger, Deputy Clerk-Treasurer Vicki Olson. All stood for the Pledge of Allegiance.

Public Comments: Cindy Jazdzewski – Concerned about the party that was held at the community building on August 13. I bartend at the Anchor Club and as I was walking home from work that night there were beer cans all over in the alley way and all over the church parking lot. I picked up two bags of beer cans. I'm concerned for the elderly church members that would have arrived early to start the coffee. You don't need one of them bending over and losing their balance because they had to pick up trash. Jeremiah and Kelsey Tilley (live two doors down from the community building) had their solar lights taken from their backyard and beer cans all over their front yard. Kelsey talked with Wade and per Wade it was that it couldn't be proven that people from this party had taken the lights. Later this week as I was walking on the backside of the community building where you go in to vote there in the rocks lay busted solar lights. Called Wade and he came down to take pictures. This isn't the first time there has been property damage from a party/event that was held at the community bldg. My request is that something should be done about the rule if you are having any type of function, especially if you are having alcohol, that you have security presence, so that on the outside of the building no one leaves with beer/wine and they also weren't getting into their vehicles. Also very concerned about how these type of parties/events are making the community look. Hawkey read a portion of the policy where it does state that they are to have a security presence - At least one security officer is required if alcohol is served on the premises with two hundred (200) or more people in attendance at any time. If alcohol is served, glass bottles shall not be allowed. There shall be no alcohol outside the Community Center or in the parking lot.

Hawkey asked Chief Barger if there had been any officer on duty the night of this incident. Chief Barger didn't believe we had anyone on duty that night. We may have to work with Brooklyn PD to make sure that someone is on duty those nights for these events. With these type of huge events, 90% of the time the parents don't know where the kids are. Events of this type should have at least one security officer. Cindy stated that the Brooklyn PD shouldn't be responsible for the party. They are here to cover the village, not to babysit the kids or those who are drinking outside of the community building. Community Building Policy to be placed on next agenda. Village Board will have to review to update this policy at the next board meeting.

Village President Report:

Place discussion about use of community building on next month's meeting. There is a website that is administered by Brit & Stacey, contacted them regarding some comments that were made on their page by Town of Brooklyn residents. Sign outside the Post Office -- sign is not because they are moving. It is an advertisement to promote buying a post office box. Siren is still not working, and we will continue to provide updates as we know more.

Hawkey made a motion to have real estate agent convey to respective parties the counter offers. Seconded by Smith. Motion carried.

Motion made by Smith to adjourn. Seconded by Crubaugh. Motion carried. Adjourned at 9:06pm

LAW of the Month

Open Burning Ordinance – Sec. 12-65. Open fires and open flames Sec. 12-66 Open burning procedures "fire pit"

Sec. 12-65. Open fires and open flames
(a) Prohibitions; definitions. "Open burning," as used herein, shall mean burning done outside of a

building. Open burning is prohibited in the village without first obtaining a "fire pit" permit, with the

following exceptions:

- (1) Small outdoor fires used for cooking, provided they are contained within a grill designed for cooking or an outdoor fireplace with a screen to contain any embers produced by burning. The burning material should not contain yard waste or rubbish.
- (2) Small open fires for welding, acetylene torches, safety flares, heating tar, or similar applications.
- (3) No burning shall be allowed on or immediately adjacent to the surface of any blacktop street.
- (4) All leaf burning is prohibited.
- (b) Substances which may be burned. The following open burning may be conducted providing a burning permit is first obtained:
 - (1) Fires set for practice and instruction of firefighters, or the testing of firefighting equipment.
 - (2) The burning of small amounts of dry combustible rubbish not to include: wet combustible rubbish, garbage, oily substances, asphalt, plastic, or rubber products.
 - (3) The burning of trees, wood, limbs, stumps, brush, or leaves; provided, however, that such materials may be burned only in those areas zoned "agricultural" or permission of the fire chief or designee.

Sec. 12-66. Open burning procedures "fire pit"

- (a) General. A campfire style fire maybe made as long as the site has been preapproved by the fire chief or designee and a "fire pit" permit has been issued to the owner, operator, or agent form the fire chief or designee authorized to issue such permits.
- (b) *Requirements*. The following are the requirements for construction of a "fire pit":
 - (1) Not nearer than ten feet to any building, in a substantial burner built of metal, concrete or brick, as approved by the fire chief or designee.
 - (2) The site should be ringed with stones of sufficient size and quantity to contain the fire.
 - (3) The site may not be located under any overhead wires.
 - (4) May not be more than four feet in diameter.
 - (5) At no point closer than ten feet from a building. At his discretion the fire chief or designee may require greater distances.
 - (6) Only wood may be burned, any may be stacked in a pile no larger than three feet high.
- (c) Application for "fire pit" permit; procedure for issuance of fire pit permit. Application for a "fire pit" permit shall be made in writing upon a form furnished by the fire chief or designee authorized to issue such permits may also establish from time to time special rules or restrictions relating to open burning. Such rules may govern conditions, including, but not necessarily limited to, the following:
 - (1) Hours when burning is allowed.
 - (2) Material which may or may not be burned
 - (3) What constitutes as approved burning device or incinerator.
 - (4) Supervision required for burning, including minimum age of supervisors and type of fire extinguishing equipment which must be present at the burn site.
 - (5) The manner in which ashes created by the burning under the permit are to be disposed of.
 - (6) Any such restrictions hereafter adopted by the fire chief which are not specifically ordained in this section shall, provided they are printed on the face of the burning permit or attached thereto, be binding upon permit applicants; any violations of such restriction shall be punishable as violations of this section.

- (d) Issuance of permit. If the fire chief or designee authorized to issue such fire pit permits, finds that the proposed burning complies with all village ordinances and the regulations of the department of natural resources as set forth in Wisconsin Administrative Code and Register, he shall officially approve the application, and a fire pot burning permit shall be subsequently issued to the applicant. A copy of any fire pot burning permit, and the application therefore, shall be kept on file with the fire chief and village clerk. If state approval is required, no local permit shall be issued until state approval is granted.
 - (1) Notice to permittee. Each permit issued shall provide notice of materials that may be burned and those which may not be burned and further notice to the permittee of possible civil and criminal penalties for violation of this section and of state regulations.
 - (2) Any ashes created by burning such material as is lawful under this section are to be disposed of in a manner authorized by law.
 - (3) Open burning shall be constantly attended and supervised by a competent person of at least 18 years of age until such fire is extinguished. This person shall have readily available for use such fire extinguishing equipment as may be necessary for the total control of the fire while burning and/or extinguishing such fire.

(e)Outdoor fireplaces/chimeras units regulated.

- (1) All outdoor fireplaces must be used according to manufacturer's recommended requirements.
- (2) All fireplaces/chimeras must be equipped with screens or containment systems to prevent the release of embers or sparks. They must be equipped with supports to protect surfaces from heat generated by the units.
- (3) All fireplaces/chimera units may only be used on concrete or other noncombustible
- (4) surfaces. The use of a unit on a wooden deck, porch, patio, or under and overhang is prohibited.
- (5) Only the burning of dry, non-treated wood is acceptable. No lawn clippings, construction materials, garbage, brush, or other yard waste is permitted.
