

SECRET BALLOT ELECTION AND

TOWN MEETING WARRANT

Tuesday, March 11, 2025

and

Saturday March 15, 2025

TO: Gloria Moore, Resident of the Town of Steuben, in the County of Washington,

GREETINGS:

In the name of the State of Maine, you are hereby required to notify and warn the inhabitants of the Town of Steuben, in said county and state, qualified by law to vote in town affairs, to meet at the Town Office Building on Tuesday the 11th of March, 2025 at 7:45 am, then and there to act upon Article 1 and by secret ballot on Articles 2, 3 and 4. The polling hours therefor to be from eight o'clock in the morning until eight o'clock in the afternoon.

And, to notify and warn said inhabitants to meet at the Steuben Fire Station on Saturday, the 15th day of March 2025 at 1pm, then and there to act on Articles 5 through 48 as set out below, to wit:

Article 1: To elect a moderator by written ballot to preside at said meeting

Article 2: To elect all municipal officers; One Selectman for a 1-year term, One Selectman for a 3-year term, One Overseer for a 1-year term, One Overseer for a 2-year term One Overseer for a 3-year term, and One Local Advisory Committee Members for a 3-year term.

Article 3: Shall an ordinance entitled 'Local Food and Community Self-Governance Ordinance' be enacted?

Article 4: Shall an ordinance entitled 'Commercial Rocket Launch Ordinance' be enacted?

The meeting will be recessed at the close of polls at 8 pm on March 11th to reconvene at the Steuben Fire Station at 1 pm on Saturday, March 15th for the purpose of voting on the following articles:

- Article 37:** To see if the town will vote to authorize the municipal officers to spend an amount not to exceed $\frac{1}{4}$ of the budgeted amount in each budget category of the 2025 annual budget during the period from January 1, 2025, to the 2025 annual town meeting.

- Article 38:** To see if the town will vote to authorize the Selectmen to sell unused equipment or other items with an estimate cash value of less than \$500 after advertising a public sale.

- Article 40:** To see if the town will vote to authorize the Selectmen to apply for and/or accept and expend, on behalf of the Town, money from Federal, State and other governmental units or private sources which may be received, from time to time in the form of Grants or any other source, during the period of March 15, 2025, until the next annual Town Meeting.
