If you are planning on building a new home or building with bathrooms etc. on a vacant lot, you will need to go to Parker County Platting Department first and present your floor plans as well as your lot survey so that they can plat it (Per City Zoning Ordinance, page 9). You will also need to apply for and be approved for a Septic Permit from Parker County. Once you have both of those, please turn those in along with this application. In addition to these requirements, if your property is in the Flood Plain, you will also have to be approved by the Parker County Flood Plain Manager to build within the flood plain. If you are not certain, you may look up your address here on the FEMA Flood Risk Maps

I have also enclosed the one page from our Planning and Zoning Ordinance that gives you the required setbacks as well as minimum square footage. All electrical and plumbing must be performed by state licensed electricians and plumbers.
