Town of Seymour Board Meeting N9296 Hwy 55, Seymour July 11th, 2024

The meeting was called to order at 5:35 pm by Chair, Michael Barclay. Present was Chair-Michael Barclay, Supervisors-Aaron Melchert and Kurt Gagnow, Treasurer-Ginny Rottier and Clerk-Darlene Schultz. Ryan Chambers from THZ went through the town policy and answered questions that the board had. It was also discussed that the French Rd bridge is not being covered under the town policy. Once the town receives the information from the person involved in the car accident Ryan will look into coverage.

Aaron Melchert made a motion to transfer \$2,331.31 from the Fire Department Capital Outlay fund to the Seymour Rural Fire Department for radios. Kurt Gagnow seconded. Carried.

The generator to be purchased for the town has been tabled until an electrician is consulted.

The road work on Hackel Rd has been completed. Due to the rain Pearl St has not been started yet.

Tom and Stefanie VanDeHei met with the Plan Commission for a request to change 2 acres of Exclusive Ag to General Ag and Special Exception to have storage buildings for a plumbing business. The Plan Commission recommended to approve these requests. Kurt Gagnow made a motion to except the Plan Commission recommendation and approve the Zoning Change and Special Exception. Roll Call Vote: Gagnow-Yes, Melchert-Yes, Barclay-Yes Carried.

Aaron Melchert made a motion to renew the \$100,000 line of credit with Nicolet Bank and have the signers be Chair, Treasurer and Clerk. Kurt Gagnow seconded. Carried.

Aaron Melchert made a motion to approve the Financial Report as presented by Treasurer, Ginny Rottier. Kurt Gagnow seconded. Carried.

Aaron Melchert made a motion to pay town orders 11766-11776 for a total of \$57,821.55. Kurt Gagnow seconded. Carried.

Aaron Melchert made a motion to adjourn at 7:16 pm. Kurt Gagnow seconded. Carried.
