## RESOLUTION OF THE TOWN BOARD OF RAVENNA TOWNSHIP, DAKOTA COUNTY, MINNESOTA, ADOPTING ASSESSMENT

*Whereus*, pursuant to proper notice duly given as required by law, the town board has met and heard and passed upon all objections to the proposed assessment for paving Otero Avenue from Hwy 316 to 6,350 feet west,

## Now Therefore, Be it Resolved:

- 1. Such proposed assessment, a copy of which is attached hereto and made a part hereof, is hereby accepted and shall constitute the special assessment against the lands name therein, and each tract of land therein included is hereby found to be benefited by the proposed improvement in the amount of the assessment levied against it.
- 2. Such assessment shall be payable in equal biannual installments extending over a period of five (5) years, the first of the installments to be payable on or before May 15, 2014 (property tax payment date) and shall bear interest at the rate of 1.25 percent per annum from the date of the adoption of this assessment resolution.
- 3. The owner of any property so assessed may, at any time prior to certification of the assessment to the county auditor, pay the whole of the assessment on such property, with interest accrued to the date of payment, to the town clerk, except that no interest shall be charged if the entire assessment is paid within 30 days from the adoption of the assessment. An owner may at any time thereafter, pay to the Dakota County Property Taxation & Records the entire amount of the assessment remaining unpaid, with interest accrued to December 31 of the year in which such payment is made. Such payment must be made before November 15 or interest will be charged through December 31 of the succeeding year.
- 4. The clerk shall forthwith transmit a certified duplicate of this assessment to the county auditor to be extended on the property on the property tax lists of the county. Such assessments shall be collected and paid over in the same manner as other municipal taxes.
