RESOLUTION APPROVING SUMMARY LANGUAGE FOR PUBLICATION OF ORDINANCE NO. 01-2015 AMENDING THE RAVENNA TOWNSHIP ZONING ORDINANCE

WHEREAS, on August 13, 2015 the Town Board of Ravenna Township adopted Ordinance No. 01-2015 amending the Ravenna Township Zoning Ordinance regarding accessory structures, temporary structures, and other items ("Ordinance");

AN ORDINANCE AMENDING THE RAVENNA TOWNSHIP ZONING ORDINANCE (Ord. No. 01-2015)

On August 13, 2015 the Town Board of Ravenna Township adopted the above referenced ordinance to amend the Ravenna Township Zoning Ordinance to more specifically address definitions, meetings, accessory structures (including garages), temporary structures, expiration of permits, driveway setbacks, waivers from driveway standards, township roads, septic inspection and pumping requirements, and communication towers. The Ordinance is effective immediately.
