**RESOLUTION APPROVING SUMMARY LANGUAGE FOR PUBLICATION
OF AN ORDINANCE ADOPTING AN UPDATED FEE SCHEDULE**

WHEREAS, on May 13, 2021 the Town Board of Ravenna Township (“Town”) adopted “AN ORDINANCE ADOPTING AN UPDATED FEE SCHEDULE FOR THE TOWN”, Ordinance Number 02-2021 (“Ordinance”);

WHEREAS, the Ordinance adopts a new fee schedule for the Town to replace the existing schedule;

WHEREAS, Minnesota Statute, section 365.125 allows the publication of a summary of an ordinance instead of publishing the entire ordinance; and

WHEREAS, the Town Board determines that publishing the full text of the Ordinance is not reasonably feasible and that publication of a summary is sufficient to clearly inform the public of the intent and effect of the Ordinance.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board hereby determines to publish the following summary language, which is hereby approved, in lieu of publishing the full text of the Ordinance:

**AN ORDINANCE ADOPTING AN
UPDATED FEE SCHEDULE FOR THE TOWN**

The Town Board of Ravenna Township adopted Ordinance No. 02-2021 to establish an updated fee schedule for the Town. The new schedule replaces the previous schedule and it goes into effect immediately. A copy of the full ordinance and fee schedule is posted at the Town Hall, is available at the Dakota County Law Library, the Pleasant Hill Library in Hastings, is on the Town’s website, and can be obtained by contacting the Town Clerk-Treasurer.

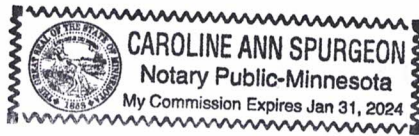
