**RESOLUTION APPROVING SUMMARY LANGUAGE FOR PUBLICATION OF AN
ORDINANCE AMENDMENT REGARDING CANNABIS BUSINESSES**

WHEREAS, on February 13, 2025, the Town Board of Ravenna Township adopted Ordinance No. 01-2025 “Ordinance Amending the Ravenna Township Zoning Ordinance Regarding Cannabis Businesses” (“Ordinance”);

WHEREAS, it is not practical to publish the entire text of the Ordinance in the Town’s official newspaper;

WHEREAS, Minnesota Statutes, section 368.01, subdivision 21 allows the publication of a summary of an ordinance instead of publishing the entire ordinance; and

WHEREAS, the Town Board determines publication of summary of the Ordinance is sufficient to clearly inform the public of the intent and effect of the Ordinance and where to access the full text of the Ordinance.

NOW, THEREFORE, BE IT RESOLVED, that the Town Board hereby determines to publish the following summary language, which is hereby approved, in lieu of publishing the full text of the Ordinance:

**ORDINANCE AMENDING THE RAVENNA TOWNSHIP ZONING
ORDINANCE REGARDING CANNABIS BUSINESSES**

On February 13, 2025, the Town Board adopted Ordinance 01-2025 to amend the Ravenna Township Zoning Ordinance regarding cannabis businesses in the Rural Residential District. A copy of the ordinance is on the Town’s website and be obtained by contacting the Town Clerk-Treasurer. The ordinance goes into effect immediately.

6. Place the Ordinance in the Town Ordinance Book within 20 days together with a copy of the affidavit of having published approved summary language and a copy of this Resolution.
