**RESOLUTION APPROVING SUMMARY LANGUAGE FOR PUBLICATION OF  
AN ORDINANCE AMENDING THE RAVENNA TOWNSHIP ZONING  
ORDINANCE REGARDING AGRICULTURAL ACCESSORY STRUCTURES**

**WHEREAS**, on June 11th, 2026, the Town Board of Ravenna Township (“Town”) adopted “An Ordinance Amending the Ravenna Township Zoning Ordinance Regarding Agricultural Accessory Structures” (“Ordinance”);

**WHEREAS**, Minnesota Statute, section 365.125 allows the publication of a summary of an ordinance instead of publishing the entire ordinance; and

**WHEREAS**, the Town Board determines that publishing the full text of the Ordinance is not reasonably feasible and that publication of a summary is sufficient to clearly inform the public of the intent and effect of the Ordinance.

**NOW, THEREFORE, BE IT RESOLVED**, that the Town Board hereby determines to publish the following summary language, which is hereby approved, in lieu of publishing the full text of the Ordinance:

**AN ORDINANCE AMENDING THE RAVENNA TOWNSHIP ZONING  
ORDINANCE REGARDING AGRICULTURAL ACCESSORY STRUCTURES**

On June 11<sup>th</sup>, 2026, the Town Board of Ravenna Township adopted the above-referenced ordinance to exempt agricultural land from the square footage and number limitations placed on accessory structures if the property contains at least 39 acres and the agricultural accessory structures are used exclusively for agricultural operations on the property. The ordinance is effective immediately and a copy of the full ordinance is posted on the Town’s website.
