Rezoning Petition / Conditional Use Permit Application Checklist

This checklist is intended to be a guide. All other requirements shall also be met. The Town of Holland Zoning Ordinance can be found on the Town's website, <https://hollandbrowncountywi.gov> under Ordinances & Resolutions.

- _____ Review the Town of Holland Zoning Ordinance to determine if your plan meets the requirements.
- _____ Contact the Town of Holland Zoning Administrator, to obtain a Conditional Use Permit Application or a Rezoning Petition, if needed.
- _____ Fill out the application completely and forward, with fees and supporting documentation to town's Zoning Administrator, John Sundelius, 1293 Holland Rd, Greenleaf, WI 54126.
- _____ The Zoning Administrator will bring your application /petition to the Town Board. If a meeting with the Planning Commission is necessary, they will set the date/time, and notify you so that you may attend and answer any questions they may have about your project.
- _____ If a Public Hearing is necessary, they will set the date for that, and it will be published. You should attend that as well. After the Public Hearing, it will go before the Town Board for approval.
- _____ When all is approved, the Zoning Administrator will instruct you to complete the Building Permit Application which is found on the Town's website. You need both a permit and inspection for the following: a) a new dwelling or building, or b) any additions or structural changes to a dwelling or building.
