- D. Vande Wettering Road, from Cty. Rd. Z to approx. 800' south x 22' wide (exclude item 6 below)

 2. 4" Stone
 3. 2" 3LT 58-28S
 4. 1.5" 4LT-58-28S
 5. Tack
 6. Asphalt driveway apron sawing and removing
 7. 2' wide CABC ¾" shoulder
 8. Traffic control

 1. 2" stone
 2. Pulverize
 3. Manhole adjustments
 4. 2" 4LT 58-28S
 5. Concrete driveway apron sawing and removing
 6. Asphalt driveway apron sawing and removing
