Federal law requires all consumer class fireworks to be labeled with appropriate rating. Town of Sylvester, Green County, Wisconsin Fireworks Permit
Wisconsin statue 167.10 prohibits the use or possession of fireworks, as defined under
167.10 (1), without a user's permit issued by the mayor of a city, president of a village or
chairperson of a town in which the possession or use is to occur. Permits can only be
issued to one of the following; 1) A public authority; 2) A fair association; 3) An
amusement park; 4) A park board; 5) A civic organization; 6) A group of resident or
nonresident individuals; 7) An agricultural producer for the protection of crops from
predatory birds or animals. NOTE: Permits cannot be issued to a minor; they must be 18
years of age, under 167.10 (3) (h). A copy of this permit shall be on file with the clerk of the
city, village or town.
