**RESOLUTION 21-10-11**

**Resolution for Ward Creation, Designation of Polling Place,  
and Combining Wards for Elections**

**WHEREAS**, the Exeter Town Board, County of Green, Wisconsin, is responsible for ward creation in the Town of Exeter.

**NOW, THEREFORE, BE IT RESOLVED** by the Exeter Town Board, Green County, Wisconsin, that the Town of Exeter will be divided into three wards as indicated on the attached map, also described as follows:

**Ward 1:** All of the territory within the boundaries of the Town of Exeter lying west of the center line of Marshall Bluff Road, west and north of the center line of Exeter Crossing Road, west of the center line of County Highway CC, north of the center line of County Highway W, and west of the center line of County Highway CC.

**Ward 2:** All of the territory within the boundaries of the Town of Exeter lying west of the center line of County Highway D, north of the center line of State Highway 92, east of the east lines of Lots Eleven (11), Ten (10), Nine (9), Eight (8), Seven (7), and Six (6) of Certified Survey Map Numbers 1393 and 1392, and north of the north lines of Lots Six (6), Five (5), Four (4), Three (3), Two (2), and One (1) of Certified Survey Map Numbers 1392 and 1391 recorded in Volume 4 of Certified Survey Maps of Green County on Pages 319 through 324 in the office of the Register of Deeds for County of Green, Wisconsin, east of the center line of State Highway 92, north of the north line of the south half of Section Ten (10) and north of the north line of the south half of Section Nine (9), Town Four (4) North, Range Eight (8) East, Green County, Wisconsin, and east of the center line of County Highway CC.

**Ward 3:** All of the territory within the boundaries of the Town of Exeter lying east of the center line of County Highway D, south of the center line of State Highway 92, west of the east lines of Lots Eleven (11), Ten (10), Nine (9), Eight (8), Seven (7), and Six (6) of Certified Survey Map Numbers 1393 and 1392, and south of the north lines of Lots Six (6), Five (5), Four (4), Three (3), Two (2), and One (1) of Certified Survey Map Numbers 1392 and 1391 recorded in Volume 4 of Certified Survey Maps of Green County on Pages 319 through 324 in the office of the Register of Deeds for County of Green, Wisconsin, west of the center line of State Highway 92, south of the north line of the south half of Section Ten (10) and south of the north line of the south half of Section Nine (9), Town Four (4) North, Range Eight (8) East, Green County, Wisconsin, east of the center line of County Highway CC, south of the center line of County Highway W, east of the center line of County Highway CC, south of the center line of Exeter Crossing Road, and east of the center line of Marshall Bluff Road.


