ORDINANCE NO. 2009-02

AUTHORIZING PLACEMENT OF WATERWAY MARKERS IN PESHTIGO RIVER

THE COMMON COUNCIL OF THE CITY OF PESHTIGO DO ORDAIN AS FOLLOWS:

Section 1 – Section 12-1-10 of Title 12 of the Peshtigo Municipal Code is created to read as follows:

SECTION 12-1-10 <u>AUTHORIZING PLACEMENT OF WATERWAY MAKERS IN PESHTIGO RIVER</u>

- (A) <u>INTENT</u>. The intent of this ordinance is to provide safe and healthful conditions for the enjoyment of aquatic recreation consistent with public rights and interest and the capability of the water resource.
- (B) <u>APPLICABILITY</u>. The provisions of this ordinance shall apply to the portion of the waters of the Peshtigo River within the corporate limits of the City of Peshtigo as more specifically set forth below.
- (C) HAZARD WARNING WATERWAY MARKERS AUTHORIZED.
 - (1) The City of Peshtigo hereby authorizes placement of Hazard Warning Waterway Markers (buoys) in the Peshtigo River at the following locations:

From Southernmost to Northernmost:

- 1. N 45 deg. 03. 799 W 087 deg. 44. 842
- 2. N 45 deg. 03. 812 W 087 deg. 44. 835
- 3. N 45 deg. 03. 819 W 087 deg. 44. 825
- 4. N 45 deg. 03. 837 W 087 deg. 44. 837
- 5. N 45 deg. 03. 842 W 087 deg. 44. 842
- 6. N 45 deg. 03. 874 W 087 deg. 44. 874
- 7. N 45 deg. 03. 908 W 087 deg. 44. 784
- (2) Placement of such markers (buoys) may be made by Riparian owners having river frontage at said locations. Such owners shall comply with all requirements of this ordinance.
- (3) All such markers (buoys) shall conform to the requirements of NR 5.09 of the Wisconsin Administrative Code and shall have affixed thereto such numbers as are assigned to them by the City of Peshtigo; such numbers are to be located at least twelve (12) inches above the waterline.

- (4) All markers (buoys) shall be removed from the water by December 1st of each year. Any marker (buoy) removed from the water pursuant to this Section may be replaced in the ensuing year after the ice is out of the water.
- (D) <u>EFFECTIVE DATE.</u> This ordinance shall take effect after passage and publication as provided by law.
