ORDINANCE NO. 2015- 01

Amendment to Section 28-23(g) of City Ordinances

That Sec. 28-23(g) of the Code of Ordinances, City of Peshtigo, Wisconsin is hereby amended to read as follows:

- (g) Throwing or shooting of arrows, stones, or other missiles prohibited.
 - (1) In furtherance of public health and safety, no person shall throw or shoot any object, arrow, stone, snowball, or other missile or projectile, by hand or by any other means at any person or at, in or into any building, street, sidewalk, alley, highway, park, playground, or other public place within the City, except as permitted by 2013 Wisconsin Act 71 as follows:
 - a. Persons may hunt with a bow and arrow or crossbow beyond a distance of 100 yards from any building located on another person's land. This restriction does not apply if the person who owns the land on which the building is located allows the hunter to hunt within 100 yards of the building; and
 - b. A person who hunts with a bow and arrow or crossbow must discharge the arrow or bolt from the respective weapon toward the ground.
 - c. "Building" means a permanent structure used for human occupancy and includes a manufactured home, as defined in Wis. Stats. §101.91(2).
 - (2) This subsection shall not apply:
 - a. To the shooting or discharging of toy arrows not suitable for hunting that have a tip made of rubber or similar material.
 - b. To a supervised archery range approved by the Common Council.
