Instructions for Zoning Permit Application

- Please note that this zoning permit application is for conduction building codes, plumbing, electrical inspections.
 - When filling out an application try to be as accurate with names, addresses, and phone numbers as possible.
 - A site visit can be conducted by the Zoning Officer at any time to verify the information.
 - Extra fees will be applied for extra inspection visits, services, or problems caused by purposely submitting false information.
1. Start Application by checking the type of work in the top left-hand corner.
 2. Fill out the number of acres owned by the landowner in the top right-hand corner.
 3. Fill in your name, address, and phone number as the applicant.
 4. Fill out the Name, address, and phone number of the landowner if not the applicant.
 5. Fill out the Name, Address, and phone number of the contractor if not the applicant.
 6. If building in a subdivision, please indicate the subdivision's name and lot number.
 7. Briefly describe your project, building, etc. If it is a building, structure, or addition you must indicate the dimensions. (example 24' x 50' garage).
 8. Leave "first-floor elevation" and "100-year flood elevation" blank
 9. Circle yes or no if the planned project is in a flood plain (if not sure the zoning officer should be able to answer that for you)
 10. Circle yes or no whether you own multiple properties within the township.
 11. In the square provided or on a separate sheet of paper show a rough sketch of the property with roads, highways, buildings, etc. please provide where and how the new project will sit on the property.
 12. Sign and date application
 13. Return application to the township Zoning Officer along with the processing fees required for the application. The Zoning officer will contact you with your approval or if more information is needed.



Guidelines for Timbering

1. Logs must be piled in the opposite direction to the run of the road
2. Log piles must be kept a least thirty (30) feet from the edge of the road
3. All loading of logs will be done from a landing at least Thirty (30) feet from the road
4. When building a landing over a ditch a minimum fifteen (15) inch culvet will be installed
5. Stump-shots and butt-ends must be kept clear at least thirty (30) feet from the edge of the road.
6. Partially felled trees are not permitted to be left suspended or hanging over any portion of the roads
7. No logs or parts of logs are permitted to be left on the ditches or drains road at any time.
8. Trucks and loading equipment are not permitted to be left along roads.

FAILURE TO COMPLY WITH THESE GUIDELINES MAY RESULT IN DISCIPLINARY ACTION BEING TAKEN BY THE TOWNSHIP SUPERVISORS, AND OR ZONING ENFORCEMENT OFFICER.

MAXIMUM PENALTY FOR NON-COMPLIANCE IS \$500.00 PER INCIDENT WITH EACH DAY BEING A DIFFERENT INCIDENT.

Road Bonding Procedures

Sugarcreek Township requires all loads over 10 tons and traveling township roads to complete the following:

- The Road Bond processing fee is \$150.00. The fee can be mail or dropped off at the Township building.
If writing a check make checks payable to Sugarcreek Township
 - Complete a Road Bond Application
 - Complete the Excess Road Maintenance
- Post a Surety Bond in the amount of \$12,600 per mile.
 - Unimproved Roads of \$6,000 per mile
- List of companies who will be hauling for the user.
