	Competed and notarized application: A signed and notarized application from the <u>property owner of record.</u>
	Property Survey: A licensed certified survey of the property, including location, existing details, structures, measurements, and boundary lines.
	Engineer Scaled Map Drawing: Including the adjoining boundaries with the City of Hayden Lake, other adjacent properties, and location of streets, easements, property lines, and driveways.
	Two sets of mailing labels for neighbor notifications (within 300' of property) for Public Hearing.
	"Will-serve" declaration from water and sewer districts.
	Fees: The applicant shall pay the city a fee of \$200.00 per lot. Additionally, the applicant shall pay the estimated cost to reimburse the city for the cost of all services provided by the city engineer, city attorney, and any other city officials as well as other directed costs associated with processing the application. Additional costs include, but are not limited to publications, notifications, signage, inspections, mailings, ordinances, agreements and legal descriptions.
