A RESOLUTION OF THE HAYDEN LAKE SEWER DISTRICT OF KOOTENAI COUNTY IDAHO ALTERING FEE SCHEDULE FOR REGULARLY CHARGED FEES

BE IT RESOLVED by the Board of Directors of the Hayden Lake Sewer District, as follows:

WHEREAS, the Hayden Lake Sewer District of Kootenai County, Idaho (“District”), is a sewer district organized and existing under and pursuant to the laws of the State of Idaho; and

WHEREAS, the Board of Directors for the District has previously adopted Ordinance Numbers 89-2 and 16-001 which, among other things, provides for the authority of the Board to set the Capitalization Fees and other necessary fees as required to pay for each User’s share of capital costs and services associated with the Collector System, Regional Treatment Facility, and services; and

AND WHEREAS, the District has also adopted fees to be charged for services and capitalization fees by prior resolution or motion, and desires to establish a fee schedule to consolidate the information for convenience, and for ease of review;

NOW THEREFORE, the Board of Directors for the District adopts fees as set forth below:


