

ORDINANCE NO. 2026-01

AN ORDINANCE OF THE HAYDEN LAKE SEWER DISTRICT, OF KOOTENAI COUNTY, IDAHO, APPROPRIATING \$3,553,834.00 TO DEFRAY THE NECESSARY EXPENSES AND LIABILITIES OF THE DISTRICT FOR THE FISCAL YEAR BEGINNING DECEMBER 1, 2026.

BE IT ORDAINED BY THE BOARD OF DIRECTORS OF THE HAYDEN LAKE SEWER DISTRICT, OF KOOTENAI COUNTY, IDAHO, as follows:

Section 1: That the sum of \$3,553,834.00 and the same is hereby appropriated to defray the necessary expenses and liabilities of the Hayden Lake Sewer District for the fiscal year beginning December 1, 2026.

Section 2: That the objects and purposes for which such appropriations are made are as reflected on the attached budget.

Section 3: That a general levy of \$80,296.00 on all taxable property within the Hayden Lake Sewer District is and the same is hereby levied for general revenue purposes for the fiscal year commencing December 1, 2026.

Section 4: This Ordinance shall take effect and be in full force upon its passage, approval, and publication in one (1) issue of the Coeur d'Alene Press, a newspaper of general circulation published in the City of Coeur d'Alene, Kootenai County, Idaho, and the official newspaper thereof.

PASSED under suspension of rules upon which a roll call vote was duly taken and duly enacted an ordinance of the Hayden Lake Sewer District at the regular meeting of the Board of Directors, held on the 2nd day of September 2026.
