Ordinance No: 7-08-1

Town Road Name Change Ordinance

SECTION I – PURPOSE

The purpose of this ordinance is to change Town road names in the Town of Cross to avoid road name duplication within Buffalo County, Wisconsin.

SECTION II – AUTHORITY

The Town Board of the Town of Cross, Buffalo County, Wisconsin, pursuant to sec. 82.03(7) Wis. Stats. Has the authority to change town road names.

SECTION III – DESIGNATION OF TOWN ROAD NAME CHANGES

- **Haeuser Rd (1) is changed to: Engel Rd**

Description: Beginning at the west side of section 27 (T20N R11W) running easterly for .36 miles and then northeasterly for .21 miles

- **Haeuser Rd (2) is changed to Mustang Rd**

Description: Section 27 (T20N R11W), intersects with Engel Rd, then proceeds southerly for .19 miles

- **Ernst Rd is changed to Jacob Kiel Rd**

Description: Section 35 (T20N R11W) beginning at the intersection with State Hwy 95 and running west and northerly for .77 miles ending in Section 34 (T20N R11W)

- **Schaffner Dugway is changed to Hensel Dugway**

Description: .98 miles running between Section 9 (T20N R11W) and Section 10 (T20N R11W)

- **Semling Rd is changed to James Way Rd**

Description: Section 23 (T20N R11W) beginning with the intersection with State Hwy 95 running southwesterly for .30 miles

- **Rotering Rd is changed to John Deere Rd**

Description: four corner intersection of Sections 13 and 24 (T20N R11W) and Sections 18 and 19 (T20N R10W) running easterly along the Section 18 and Section 19 (T20N R10W) line for .18 miles

- **Putz Rd (1) is changed to Putz Rd**

Description: Section 4 (T20N R11W) beginning at the intersection with Canada Ridge Rd and running westerly for .41 miles until the Waumandee Town line

- **Putz Rd (2) is changed to Leonards Rd**

Description: Section 3 (T20N R11W) beginning at the intersection with Schaffner Valley Rd running .36 miles in a northeasterly manner

- **Wicka Rd is changed to Coyote Rd**

Description: Section 30 and Section 31 (T20N R10W) line, beginning with the intersection with Doelle Valley Rd and running due west on Section 30 and Section 31 line, then northerly for a total of .32 miles

- **Lettners Field Rd is changed to Lettners Rd**

Description: Section 15 (T20N R11W) beginning at the intersection with Schaffner Valley Rd and running in a southwesterly manner for .07 miles

- **Litscher Field Rd is changed to Jesse James Rd**

Description: Section 31 (T20N R10W) beginning at intersection with Buehler Valley Rd going north, .02 miles

SECTION IV – ADOPTION OF ORDINANCE

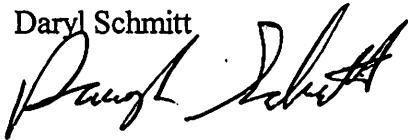

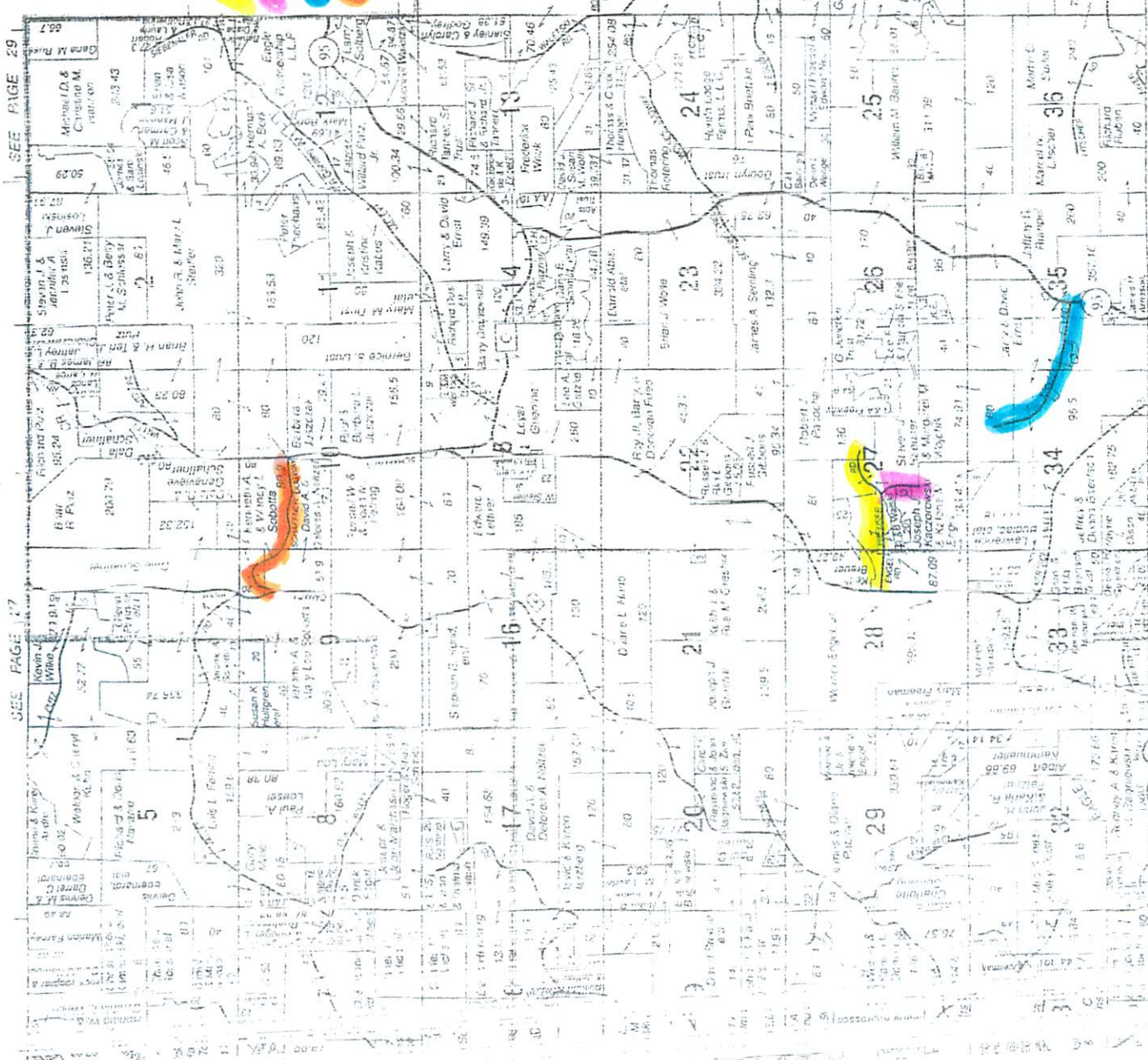

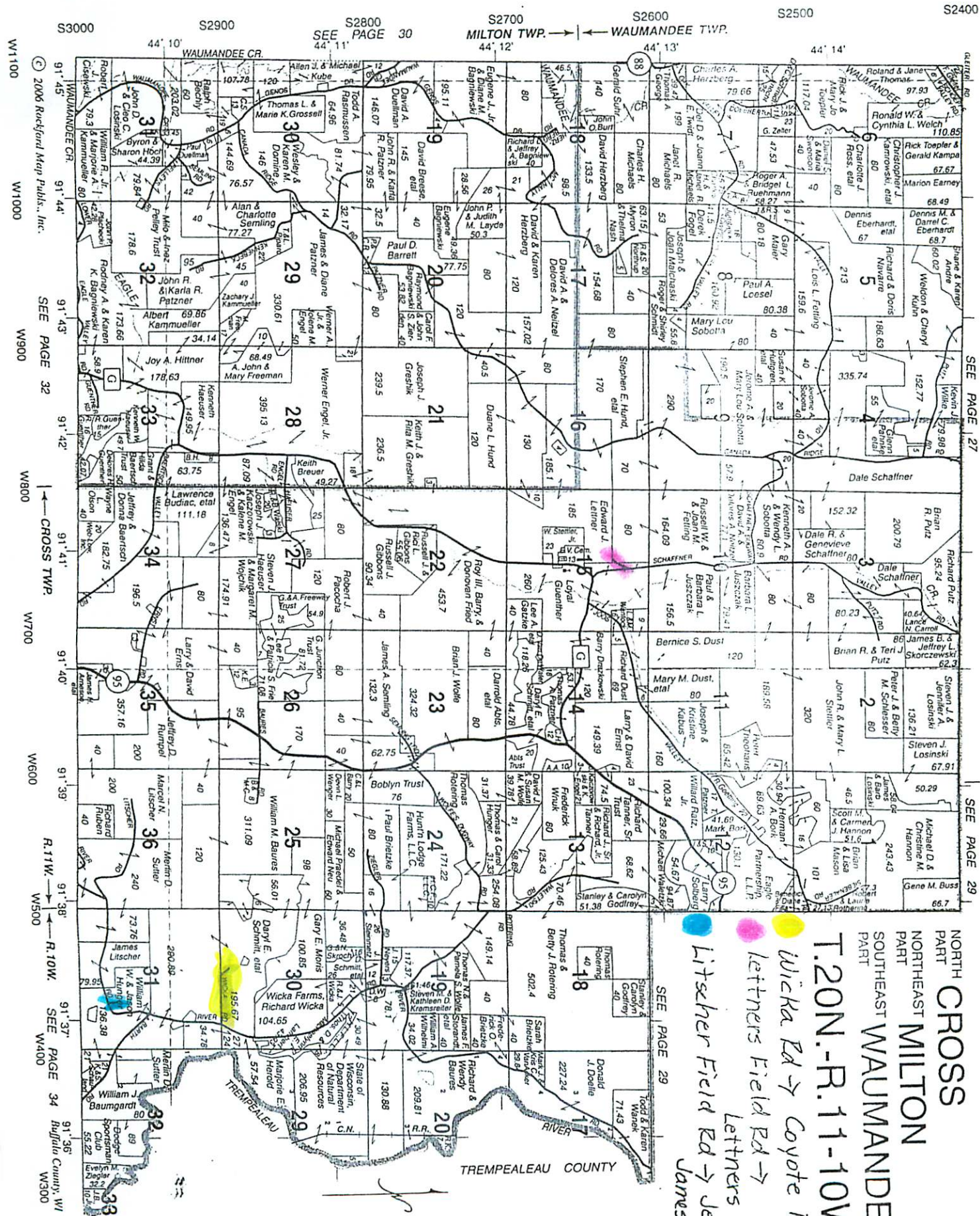
