#### Roster:

We finished Q1 with 19 on roster; which includes 1 Cadet. We do have one applicant needing action.

Not reflected above but in Q1 2020, we had 3 staff in Fire Instructor Classes; which have been put on hold due to COVID-19. Chief Lepper was also working with MSTC to schedule a "Driver/Operator" class in Stevens Point, made up mostly of PRFD personnel. This also has been put on hold for now.

#### **Equipment:**

On February 24 our Squad was down, but only for a few hours. We were paged for a fire in Plover, and the squad threw 2 of its 3 engine belts. Assistant Chief Kraft drove it with no power steering. Chance was able to replace all 3 belts a short time later.

We ordered a substantial about of turnout gear for firefighters in January due to wear and tear or expiration.

Due to COVID-19, commercial fire inspections are on hold. We need to complete annual compliance testing but that too is on hold for now (hose testing, ladder testing, SCBA testing, pump testing, etc.). Training is currently happening on-line.
