From the Village President –

Dear Park Ridge neighbors,

Planning continues to be a big priority for the Village, as evidenced by the work over the past year by our Comprehensive Plan Committee (CPC), chaired by Lee Bendtsen, and our more recently-created Strategic Planning Task Force (SPTF), chaired by Matt Chitwood.

Thanks to the leadership of Lee and Matt and the steadfast commitment of their committee volunteers, both groups are aiming to complete their immediate assignments on schedule in the coming months: CPC – to update the Village’s Comprehensive Plan (per Wis. Stats. § 66.1001); and SPTF – to assist the trustees in identifying, clarifying and prioritizing the Village’s needs with citizen input, and recommending a strategy for managing the financial resources necessary to meet these needs over time.

The work of these two committees is not only necessary and important but also, in many ways, urgent. The strategic planning work of SPTF is particularly timely, as the Village will soon need to make crucial decisions regarding important services and infrastructure. SPTF has met at least once every single month since May. They planned and hosted the “It Takes a Village to Imagine a Future” public participation event on October 27, attended by 35 Village resident participants. Also in October, they conducted an on-line Park Ridge Community Survey and received responses from 75 residents.

The SPTF, along with UW Extension professionals Nathan Sandwick (Portage County) and Daniel Foth (UW-Madison), are continuing to gather public input and will be working on developing a proposed list of the Village’s top priorities based on this input. The group plans to host another public participation event in the coming weeks to seek additional feedback from Village residents. As part of this process, they will also be drafting and sharing a Village mission, vision and values statement for residents to consider.

Judging by the input you have given us so far, we as a Village have a lot of work to do. Survey respondents, for example, told us their most important priorities are to improve our streets, our access to safe drinking water, our fire protection, our snow removal services, and our storm water management. All of these would require significant expenditures. Investments to address these important needs have been deferred for many years, perhaps in the trustees’ good faith efforts to be frugal and to keep property taxes low. However, judging by feedback we received from you, our residents, it appears we have reached a point where we can no longer kick the can down the road. As a neighbor and fellow resident recently told me, we have a “hidden debt” that needs to be addressed.

Village Caucus scheduled for January 19

Please mark your calendar for the 2022 Village Caucus, scheduled for 5:30 p.m. Wednesday, January 19, 2022 in the All Purpose Lodge at Iverson Park (top of the hill, next to the skating rink and toboggan slides). The Caucus will be held in-person and face masks will be required.

What is a “Caucus”? Simply put, it is a method used by many towns and villages for nominating candidates to be placed on the Spring Election ballot. The caucus is open to the public, but only qualified electors of the municipality may nominate and vote for candidates. A person is not required to be a registered voter in order to participate in the caucus.

This year’s Village Caucus will determine

But there is good news. First, most of you – over 70% – who participated in the on-line survey told us you would support an increase in taxes if it were necessary to fund important improvements. Second, the Village’s current tax mill rate is just \$16.72, significantly lower than the \$25.14 mill rate for Stevens Point residents. It is also the *lowest rate among urban municipalities in the County, including the villages of Whiting, Plover, Junction City, Rosholt and Amherst.* This suggests we have an opportunity to support the improvements we want for our Village. But this will require responsible decision-making based on public input, creative financing, and...a plan!

Stay tuned. Get involved in the next phase of public participation. Tell us what you think. We are all in this *together.* ■

Budget takeaways for 2022

Here are some key takeaways from the 2022 Village budget:

- Following a trend of recent years, the Village's total **revenues continue to fall short of expenditures**, making it necessary to allow for a draw from reserves (\$14,506) again this year. This of course is not sustainable, and we will be seeking solutions as part of our strategic planning work.
- Due to considerable feedback from residents, the Village reinstated its longtime annual **support for the City parks** in the amount of \$2,778.
- The Village's current tax mill rate is just \$16.72 per \$1,000 of assessed valuation, significantly lower than the \$25.14 mill rate for City of Stevens Point residents. It is also the **lowest mill rate among urban municipalities in the entire County, including the villages of Whiting, Plover, Junction City, Rosholt and Amherst.** ■

2022 DOG LICENSE APPLICATION**

Pursuant to Section 174.052, Wisconsin Statutes, all dog owners in Portage County are required to vaccinate their dogs against rabies and obtain dog licenses. All dogs five (5) months of age and older require a license. Wisconsin Statutes require evidence that a dog is currently immunized against rabies before a dog license can be issued.

All current 2021 licenses expire on December 31, 2021. A \$5.00 late fee will be charged any owner failing to obtain a 2022 license by March 31, 2022.

If you own any dogs five (5) months of age or older, please fill out the form below and return it with the proper fee to the Village Clerk. Please make your check payable to 'VILLAGE OF PARK RIDGE'.

Please include a copy of your pet's current rabies vaccination certificate with your application. It will be returned to you along with your new license. **NO LICENSE WILL BE ISSUED UNTIL PROOF OF CURRENT RABIES VACCINATION IS PROVIDED.** CONTACT YOUR VETERINARIAN FOR A REPLACEMENT RABIES VACCINATION CERTIFICATE IF YOU CANNOT LOCATE THE ONE GIVEN TO YOU AT THE TIME OF VACCINATION.
