Whereas the Town of Little Rice provides a convenient site for public deposit of refuse and recyclable materials, and

Whereas this location is commonly referred to as the Transfer Site, located at the Town of Little Rice property at 3737 County Y, Little Rice, and

Whereas the Town of Little Rice is bound by regulatory requirements pursuant to State of Wisconsin Statutes related to the collection of materials at the Transfer Site,

Therefore, The Town of Little Rice, in all efforts to remain in regulatory compliance, do hereby set the following conditions for public access to the Transfer Site:

- 1] The Transfer Site will be open for public access as determined by official action of the Town Board, with hours posted at the entrance to the Site.
- 2] Use of the Transfer Site is limited to the following conditions:
- A. Persons regularly residing within the Town of Little Rice, having numbered street addresses, not assigned to commercial operations.
- B. Persons listed as real estate property taxpayers within the Town of Little Rice, excluding properties listed as commercial operations.
- C. Commercial operations such as retail stores, campgrounds, resorts, taverns, restaurants, Tourist Rooming House, or such other operations as determined by the Town Board are strictly forbidden from using the Transfer Site.
 - D. Persons found to be abusing this service may be forbidden from access.
- 3] Those persons desiring to have access to the Transfer Site must make application to the Transfer Site coordinator and will be issued an identification card/permit which must be displayed to the attendant when entering the Transfer Site. Permit is free of charge and application is available at the Town Office or online at the Town of Little Rice web site. Permit is valid for the calendar year and must be renewed annually.

Persons not in compliance with these conditions will not be permitted to access the Transfer Site.
