D COM Amending Town of Avon Ordinance No. 2018-01, entitled "Disposal of Solid Waste at the Town of Avon Town Hall"

The Town Board of the Town of Avon, Rock County, Wisconsin, pursuant to its authority under s. 289.22, Wis. Stats., and general authority under its village powers under s. 60.22(3), Wis. Stats., does hereby amend the Town of Avon "Disposal of Solid Waste at the Town of Avon Town Hall" ordinance and ordains as follows:

Section 4: Coverage is repealed and recreated as follows:

A. Any and all Dumpsters provided by the Town and located at the Town Hall shall be for the benefit and use of Town Residents only. The intended use of the Dumpsters shall be restricted to the dumping of Solid Waste produced in connection with Residential Activities. Any use other than the intended use shall be a violation of this ordinance.

B. Hours of operation are 7 a.m. to 9 p.m.

C. Town Residents and non-residents are prohibited from placing any item outside of the Dumpsters, including but not limited to: yard waste such as leaves, grass, plants, dirt, mulch, etc.; tires; mattresses; indoor or outdoor furniture; household appliances such as refrigerators, stoves, furnaces, air conditioners, water heaters, fans, lights, etc.; electronics such as TVs, radios, computers, printers, and related items and accessories; kitchen and bathroom fixtures such as toilets, sinks, bathtubs, etc.; building materials such as wood, metal, brick, concrete, siding, shingles, gutters, fencing, etc.; powered or non-powered outdoor equipment such as lawnmowers, snowblowers, chainsaws, ATVs, fertilizer spreaders, trailers, wheelbarrows, shovels, etc.; recreational equipment such as treadmills, weightlifting equipment, bicycles, boats, swing sets, etc.; motorized vehicles, parts and accessories. Each item placed outside of the Dumpsters shall be considered a separate violation of this ordinance.
