A resolution to allocate an unbudgeted increase in PILT revenue

WHEREAS an unbudgeted increase in DNR PILT (payment in lieu of taxes) has resulted in additional revenue of approximately \$3,982 for the Town of Avon in Fiscal Year 2022;

WHEREAS the maintenance and rehabilitation of roads is a vitally important service provided to Town residents;

WHEREAS road defects such as potholes and latitudinal cracks can continually worsen over time and require a significant amount of labor and expense to manage on a perpetual basis;

WHEREAS the PASER Manual for Asphalt Roads recommends that a thin non-structural overlay (i.e. paver patch) is an effective treatment for roads in such condition;

WHEREAS the cost of paver patching in Fiscal Year 2022 decreased roughly 1% from Fiscal Year 2021, and that the current state of inflation and extraordinary volatility in the financial and commodity markets makes future cost forecasting extremely difficult and unpredictable;


THEREFORE BE IT RESOLVED that the Town of Avon Town Board, adopted by a two-thirds majority vote of the Town Board under s 65.90(5), Wis. Stats., has elected to allocate all of the unbudgeted revenue increase to the Road Work expense account for Fiscal Year 2022 to allow for additional paver patching on Town roads.


