WHEREAS Rock County Emergency Management has prepared a multi-hazard mitigation plan, hereby known as the "2023 Rock County Hazard Mitigation Plan" in accordance with federal laws, including the Robert T. Stafford Disaster Relief and Emergency Assistance Act, as amended; the National Flood Insurance Act of 1968, as amended; and the National Dam Safety Program Act, as amended; and

WHEREAS the Town of Avon has participated jointly in the planning process with Rock County and the other local units of government within the County; and

WHEREAS the 2023 Rock County Hazard Mitigation Plan identifies mitigation goals and actions to reduce or eliminate long-term risk to people and property in the Town of Avon from the impacts of future hazards and disasters; and

WHEREAS adoption by the Town of Avon demonstrates its commitment to hazard mitigation and achieving the goals outlined in the 2023 Rock County Hazard Mitigation Plan; and

WHEREAS an updated hazard mitigation plan is required by FEMA as a condition of future grant funding for mitigation projects.

THEREFORE BE IT RESOLVED that the Town of Avon adopts the 2023 Rock County Hazard Mitigation Plan as an official countywide mitigation plan. Subsequent plan updates following the approval period for this plan will require separate adoption resolutions.
