A resolution regarding the allocation of proceeds from the sale of lots in a Town of Avon cemetery

WHEREAS Town of Avon Ordinance 2019-02 states that every Town of Avon cemetery is owned, operated, directly controlled and maintained by the Town of Avon; and

WHEREAS all landscaping, mowing and general care of lots, as well as other work, construction or maintenance in a Town of Avon cemetery shall be performed by Town of Avon officers, employees, independent contractors or agents; and

WHEREAS the cost of providing said services is unpredictable and can fluctuate from year to year.

THEREFORE BE IT RESOLVED that 100% of the proceeds from the sale of cemetery lots shall be allocated to the Town of Avon perpetual care account, and that the perpetual care account's funds shall be used exclusively for the landscaping, mowing and general care of lots, as well as other work, construction or maintenance in a Town of Avon cemetery.

THEREFORE BE IT FURTHER RESOLVED that authorization for the use of funds from the perpetual care account to perform work in a Town of Avon cemetery shall be adopted by a majority of the Avon Town Board on a roll call vote with a quorum present and voting and proper notice having been given.
