Schedule of Fees

The Town Board of the Town of Avon ("Town Board") does hereby resolve to establish the following fees for permits, licenses, cemetery lots and various services in the Town of Avon ("Town"). The Town Board further resolves that this schedule of fees is intended to replace the existing fee schedule adopted by the Town Board on January 6, 2003.

Building Fees

Building permits can be obtained through the Town building inspector. For applications and miscellaneous inspections, contact the Town clerk. Fees are as follows:

New Home	under 2,200 ft ² – \$700 over 2,200 ft ² – 32 cents per square foot
Commercial Building	under 2,860 ft ² – \$1000 over 2,860 ft ² – 35 cents per square foot
Outbuilding, i.e. garage, pole barn	\$150 foundation \$250 foundation + electric \$350 foundation, electric + plumbing and/or HVAC
Driveway	\$200
Additions	\$400
Alterations	\$200
Electric	\$150
In-ground Swimming Pool	\$300
Solar Energy System – Accessory Use	\$200
Solar Energy System – Principal Use	\$3000
Wireless Tower	\$3000
Application – Rezoning	\$225
Application – Conditional Use	\$225
Application – Board of Adjustment	\$175
Miscellaneous Inspections (nuisance, non-compliance, etc.)	\$50 per hour/visit
Starting Work Without Proper Permit	Applicable permit fee doubles

Cemetery Fees

Pursuant to its authority granted under s. 157.50(2) and 157.114(2), Wis. Stats., the Town Board deems it prudent to create a fee schedule for cemeteries under Town management.

Fees are as follows:

- \$250 per cemetery lot for Town residents
- \$450 per cemetery lot for non-residents
- Up to \$300 for burial services in difficult weather conditions to cover additional costs for grave opening, snowplowing, landscape restoration, etc.

Dog Licensing

Pursuant to s. 174.05, Wis. Stats., the owner of a dog more than 5 months of age on January 1 of any year, or 5 months of age within the license year, shall annually, or on or before the date the dog becomes 5 months of age, pay the dog license fee and obtain a license (except as provided in s. 174.054, Wis. Stats.). Fees are as follows:

- Male or female, unaltered – \$8
- Neutered male or spayed female – \$3
- Multiple dog/kennel license (set of 12 tags) – \$35
- Tags in excess of kennel license – \$3

Dog licenses are available through the Town treasurer and must be obtained by April 1 of any year or an additional \$5 late fee will be applied. Additionally, failure to comply with Wisconsin's Dog Licensing Statute may result in a fine of up to \$500, plus the costs of prosecution, including court costs and reasonable attorney fees, for each offense. Each dog that is improperly licensed shall constitute a separate offense.

Records Requests

Digital copies of Town ordinances and resolutions can be downloaded free of charge from the Town website. Hard copies are also available through the Town clerk. Any other open records requests can also be initiated through the Town clerk. Fees are as follows:

- Ordinances & Resolutions, hard copy – 15 cents/page, plus \$20/hour admin fee
- Open Records Request, hard copy – 15 cents/page, plus \$20/hour admin fee
- Open Records Request, emailed – \$1 transmission fee for every 20MB, plus \$20/hour admin fee
- Open Records Request, USB flash drive – \$15 per 32GB drive, plus \$20/hour admin fee

BE IT RESOLVED that all actions taken by the Town Board with respect to the matters contemplated under this Resolution are hereby ratified, confirmed and approved.


