

Town of Grafton Ordinance No. 2011-08

AN ORDINANCE AMENDING TITLE 2 CHAPTER 1 GENERAL PROVISIONS AND ELECTIONS INTO THE CODE OF ORDINANCES, TOWN OF GRAFTON, WISCONSIN

WHEREAS, Wisconsin Statute § 5.15 requires every City, Village or Town, over 1,000 in population, to be divided into wards according to the final published results of the most recent federal census, and

WHEREAS, the Town of Grafton has been directed by State law and the Ozaukee County Redistricting Plan to divide the Town of Grafton into wards pursuant to the 2010 federal census results, and

WHEREAS, Town staff has divided the Town of Grafton into wards making a good faith effort to accommodate the "Tentative Supervisory District Plan" and to create a plan that permits the creation of lawful supervisory districts, and

WHEREAS, based on the above, it is deemed to be in the best interest of the Town of Grafton that the Municipal Code of the Town of Grafton be further modified and amended in the manner hereinafter more particularly set forth below.

NOW, THEREFORE, the Town Board of the Town of Grafton does hereby ordain as follows:

Section 1:

Section 2.1.8 of the Town of Grafton Code of Ordinances is hereby amended as provided below by adding the underlined language and deleting the language struck out:

2.1.8 Ozaukee County Supervisor Districts. Town Wards.

Five Town Wards shall be formed into Ozaukee County Supervisor Districts as follows:

2.1.8.01 Ozaukee County Supervisor District 6

Ward 3 will be combined with wards from the Towns of Belgium and Port Washington and the Village of Saukville to form County Supervisor District 6:

Ward 1

Ward 1 will be formed from a portion of County Supervisory District 9 and combined with wards from the Town of Cedarburg and be comprised of census blocks: 4004, 4005, 4006, 4007, 4008, 4009, 4010, 4011, 4014, 4059, 4060, 4061, 4062, 4064, 5014, 5015 and 5016

2.1.8.02 Ozaukee County Supervisor District 11

Wards 1, 2 and 4 will be combined with wards from the Villages of Grafton and Saukville to form County Supervisor District 11.

Ward 2

Ward 2 will be formed from a portion of County Supervisory District 10 and be comprised of census blocks: 1017, 1018, 1026, 1027, 1028, 1029, 1030, 1031, 1032, 1033, 1034, 1035, 1036, 1037, 1038, 1039, 1062, 1063, 1064, 1070, 1071, 1072, 4000, 4001, 4002, 4003, 4015, 4016, 4017, 4018, 4019, 4020, 4021, 4023, 4024, 4025, 4026, 4027, 4028, 4029, 4030, 4031, 4032, 4033, 4035, 4036, 4039, 4040, 4042, 5000, 5001, 5002, 5018, 5020, 5021 and 5027

2.1.8.03 Ozaukee County Supervisor District 12

Ward 7 will be combined with wards from the Town of Grafton and Village of Grafton to form County Supervisor District 12.

Ward 3

Ward 3 will be formed from a portion of County Supervisory District 10 and be comprised of census blocks: 1002, 1003, 1005, 1007, 1008, 1009, 1012, 1013, 1015, 1016, 1041, 1042, 1043, 1044, 1045, 1046, 1047, 1048, 1049, 1050, 1051, 1057, 1058, 1065, 1066, 1067, 2030, 2031 and 2058

2.1.8.04 Ozaukee County Supervisor District 15

Ward 6 will be combined with wards from the Village of Grafton to form County Supervisor District 15.

Ward 4

Ward 4 will be formed from a portion of County Supervisory District 10 and be comprised of census blocks: 1068, 1069, 2025, 2026, 2027, 2033, 2034, 2035, 2036, 2037, 2038, 2039, 2040, 2041, 2043, 2044, 2047, 2048, 2049, 2050, 2051, 2052, 2053, 2059, 2060, 3008, 3014, 3015, 3016, 3018, 3019, 3020, 3021, 3028, 3029 and 3030

2.1.8.05 Ozaukee County Supervisor District 23

Ward 5 will be combined with wards from the City of Mequon to form County Supervisor District 23.

Ward 5

Ward 5 will be formed from a portion of County Supervisory District 13 and be comprised of census blocks: 1059, 1060, 2013, 2014, 2015, 2018, 2020, 2021, 2022, 2024, 2028, 2029, 2032, 2055, 3009, 3010, 3022, 3024, 3025, 5001, 5005, 5006, 5015, 5016, 5018, 5023 and 5024

Section 2:

Except as hereinabove specifically modified, the Code of Ordinances, Town of Grafton, Wisconsin, shall remain in full force and effect exactly as originally adopted and previously amended. All ordinances or parts of ordinances inconsistent with or in contravention of the provisions of this Ordinance are hereby repealed.

Section 3:

This Ordinance shall take effect and be in full force from and after its passage and publication or posting.
