

Town of Grafton Ordinance No. 2012-01

TOWN OF GRAFTON ORDINANCE AMENDING TITLE 8 – MOTOR VEHICLES AND TRAFFIC; CHAPTER 1 – TRAFFIC AND PARKING, REDUCING THE SPEED LIMIT ON ULAO ROAD BETWEEN HIGHWAY C (CTH C) AND LAKESHORE ROAD FROM 55 MPH TO 45 MPH

WHEREAS, the Town of Grafton has the authority to modify speed limits on roads and highways within its jurisdiction, pursuant to Wis. Stat. § 349.11; and

WHEREAS, the Town Board believes reducing the specified speed limit will protect the health, welfare and safety of Town residents; and

WHEREAS, Town residents presented a petition requesting the reduction of the speed limit due to local conditions and in the interest of public safety; and

WHEREAS, a Notice of Public Hearing before the Town Board was duly published in the Ozaukee Press on December 22, 2011 and December 29, 2011; and

WHEREAS, a Public Hearing was held before the Town Board on January 11, 2012 regarding the proposed Amendment to the Town's Code of Ordinances; and

WHEREAS, based upon the above, it is deemed in the best interests of the Town of Grafton that Section 8.1.2.04 of the Town of Grafton's Code of Ordinances regulating the speed limit on Ulao Road be modified and amended in the manner herein set forth.

NOW, THEREFORE, BE IT ORDAINED by the Town Board of the Town of Grafton, Ozaukee County, Wisconsin, that Title 8, Chapter 1, Traffic and Parking, of the Code of Ordinances, Town of Grafton, Wisconsin, be amended as follows:

Section 1:

Title 8, Chapter 1 of the Town Code of Ordinances is amended as provided below by adding the underlined language to Section 8.1.2.04(B)(1):

8.1.2.04 Speed Limits

(B) Speed Limits Increased or Established.

The speed limits are increased or established as hereinafter set forth in this subsection upon the following streets or portions thereof between the limits designated:

- (1) A Forty-Five (45) Mile Per Hour Speed Limit On The Following Highways:
 - (a) Ulao Road between CTH C and Lakeshore Road

Section 2:

Except as hereinabove specifically modified and amended, the Code of Ordinances, Town of Grafton, Wisconsin, shall remain in full force and effect exactly as originally adopted and previously amended. All ordinances or parts of ordinances inconsistent with or in contravention of the provision of this Ordinance are hereby repealed.
