



Town of Grafton Ordinance No. 2015-01

**AN ORDINANCE AMENDING TITLE 8, CHAPTER 1, TRAFFIC AND PARKING –
CONTROLLED INTERSECTIONS AND STREET TRAFFIC REGULATIONS OF THE
CODE OF ORDINANCES, TOWN OF GRAFTON, WISCONSIN, ADDRESSING
STOP SIGNS AND HEAVY TRAFFIC ROUTES THROUGHOUT THE TOWN**

WHEREAS, it is deemed to be in the best interest of the Town of Grafton that the Municipal Code of the Town of Grafton be further modified and amended in the manner hereinafter more particularly set forth; and

WHEREAS, a Notice of Public Hearing before the Town Board was duly published in the *Ozaukee Press* on February 19, 2015, and February 26, 2015; and

WHEREAS, a Public Hearing was held before the Town Board on March 11, 2015, regarding the proposed Amendments to the Town's Code of Ordinances; and

WHEREAS, based on the above, it is deemed to be in the best interest of the Town of Grafton that the Municipal Code of the Town of Grafton be further modified and amended in the manner hereinafter more particularly set forth below.

NOW, THEREFORE, the Town Board of the Town of Grafton does hereby ordain as follows:

Section 1:

Section 8.1.2.02 of the Town of Grafton Code of Ordinances is hereby amended as provided below by adding the underlined language and deleting the language struck out:

8.1.2.02 Stop Signs

Operators of vehicles approaching a stop sign shall stop before entering a highway as required by Sec. 346.46, Wis. Stats.

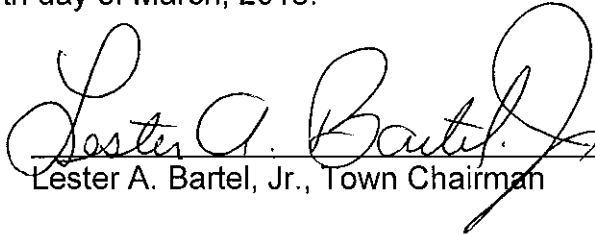
Section 2:

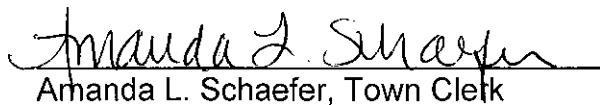
