



## Q2 Over the past few years, how has the quality of life changed in the Town of Grafton?




### Q3 Indicate the extent of which you believe the following factors contribute to the quality of life in the Town of Grafton.

### Q8 How would you rate the overall voting experience?





## Q10 Do you think the Town of Grafton has enough public "passive recreation" land such as multi-use trails?






