## **ROAD BOND AND LANDSCAPE BOND - POSTING FORM**

**INTENT -** Road Bonds protect the Town of Grafton from any costs associated with the repair and/or reconstruction of Town roads due to truck traffic associated with work being done in a surrounding area. Landscape Bonds ensure that an area that is disturbed is properly restored.

**REQUIREMENTS** - A Building Permit will not be issued until a cash bond has been posted by the applicant for each building permit. The bond will be retained by the Town of Grafton until an Occupancy Permit has been issued. In the event that any damage is caused as a result of construction, or any dirt, ground, soil, organic material or any other debris is deposited, tracked, pushed, or left on the pavement or shoulder of any public road as a result of construction, the bond will be used to defray the Town's expenses to repair any such damages or cleanup work as deemed necessary. In the event that repairs/clean up exceed the posted bond, it is the responsibility of the property owner to pay for the amount due. If the property owner fails to pay, all outstanding balances, plus interest, will be placed on the tax bill. All Landscape Bonds will be returned after it is deemed that 80% of the disturbed area has been restored.
