



House Replacement Agreement

WHEREAS, the undersigned applicant is building a new home on the applicant's property located at 848 stonytown Road in the Town of Oregon, while continuing to live in the original home; and
WHEREAS, applicant is allowed to have only one residence on the property; and
WHEREAS, the Town of Oregon has an interest in seeing the new home completed in accordance with the Town of Oregon's Building Code in a timely fashion;
NOW, THEREFORE, the applicant and the Town of Oregon hereby agree as follows:
 Within 30 days of completion of the new home, the applicant will relocate all household personal property to the new home. With 30 days of occupancy of the new home, the water supply plumbing and sewer access in the original home will be disconnected, and the original home shall be considered uninhabitable and unfit for human habitation. Within 90 days of occupancy of the new home, the original home shall be removed and the site re-graded within 90 days or as weather permits. If the existing well and septic system are not used for the replacement dwelling they must be properly sealed and abandoned unless applicant provides proof that all current state and county sanitation and groundwater protection standards are met. Under these conditions, the applicant can petition the Town Board for a variance
to maintain the well and/or septic system for another specified use. 4. If applicant fails to complete construction of the new house before the expiration of the building permit and fails to procure an extension of the completion date from the Town of Oregon, the applicant consents that the Town of Oregon may proceed under Section 66.0413 of the Wisconsin Statues to compel completion of
the razing and removal of the new house. 5. Applicant agrees to indemnify and hold harmless the Town of Oregon from any and all claims for personal injuries or property damage arising out of or related to the use or occupancy of the new house prior to its completion date as set forth in Section 4 of this Agreement.
WHEREAS, the applicant's signature on this document confirms the applicant's approval and future compliance with this agreement. Failure to comply with the terms and conditions of this Agreement in a timely fashion may also lead to other enforcement action by the Town of Oregon.
