**RESOLUTION TO ACCEPT OWNERSHIP OF
THE LAKE HARRIET CEMETERY**

WHEREAS, property known as the “Lake Harriet Cemetery” is located on Highway D in the Town of Oregon, Dane County, Wisconsin (Parcel ID No. 042/0509-092-8610-8) (“Cemetery”); and

WHEREAS, the Cemetery has been in use since at least 1851; and

WHEREAS, the Town Board is unsure of the ownership of the Cemetery but has at times acted in a fashion consistent with the Town’s ownership of the Cemetery; and

WHEREAS, there is no current cemetery authority, association, or group as those terms are used in Wisconsin Statutes Chapter 157 acting to ensure the care and maintenance of the Cemetery such that the Cemetery may be deemed to be abandoned; and

WHEREAS, the Town Board has the obligation to take charge of any cemetery which has been abandoned within the Town pursuant to Wis. Stat. §157.115(1) (c).

NOW THEREFORE, the Town Board of the Town of Oregon, Dane County, Wisconsin does hereby formally accept ownership of the Lake Harriet Cemetery and the obligation to manage and care for the Cemetery at the expense of the Town.

The above and foregoing Resolution was duly adopted at a regular meeting of the Town Board of the Town of Oregon on the 8th day of July, 2025.
