TOWN RESOLUTION 03-2026

**RESOLUTION AUTHORIZING PARTICIPATION IN A COOPERATIVE PLANNING PROCESS
PURSUANT TO WISCONSIN STATUTE SECTION 66.0307**

WHEREAS, the Town of Oregon and the Village of Oregon, both located in Dane County, Wisconsin, recognize the importance of cooperative planning to promote orderly growth and development within their respective communities; and

WHEREAS, the Town of Oregon desires to establish a process for preparing and negotiating a Cooperative Plan with the Village of Oregon to address future boundary adjustments, land use, municipal services, and related planning matters; and

WHEREAS, Wisconsin Statute Section 66.0307 provides a legal framework for municipalities to prepare and adopt Cooperative Plans addressing municipal boundaries and related planning and service-delivery matters, subject to approval by the Wisconsin Department of Administration; and

WHEREAS, the Town of Oregon desires to participate with the Village of Oregon in preparing and negotiating a Cooperative Plan to enhance intergovernmental cooperation, improve service delivery, and promote coordinated and efficient land use planning; and

WHEREAS, the Cooperative Plan will be prepared for the general purpose of guiding and accomplishing coordinated, adjusted, and harmonious development of the territory covered by the Plan, consistent with the existing and future needs of the participating municipalities and the general welfare of their residents; and

WHEREAS, it is in the best interest of the Town of Oregon to participate in a collaborative process with the Village of Oregon to address boundary-related issues and develop a mutually beneficial Cooperative Plan.

NOW, THEREFORE, BE IT RESOLVED by the Town Board of the Town of Oregon, Dane County, Wisconsin, as follows:

1. **Authorization to Prepare and Negotiate.** The Town of Oregon is hereby authorized to participate with the Village of Oregon in preparing and negotiating a Cooperative Plan pursuant to Wisconsin Statute Section 66.0307.
2. **Public Involvement and Transparency.** The preparation and negotiation of the Cooperative Plan shall include opportunities for public input as required by Wisconsin law and shall be conducted in accordance with applicable open meetings and public records requirements.
3. **Joint Public Hearing.** The Town of Oregon and Village of Oregon shall conduct a joint public hearing on any resulting draft Cooperative Plan as required by Wisconsin Statute Section 66.0307.
4. **Notice.** The Town Clerk is directed to provide notice of this Resolution within five (5) days of its adoption to the parties identified in Wisconsin Statute Section 66.0307(4)(a).
5. **Effective Date.** This Resolution shall take effect immediately upon its adoption by the Town Board.

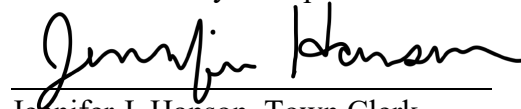
