We once again are entering the turtle-nesting season and have had several reports about turtles being run over in the nesting areas around the lake. We are hoping that we can educate drivers to slow down and if possible help them through their Journey. Doug and Leah Maurer have donated 25 yard signs to be put out in areas that have been seen as crossing areas. If you're interested in putting a sign out, please contact me and we can deliver the sign to your property.

At the annual meeting on August 15th we will have 2 board seats up for election. The terms are for 3 years and will start after the annual meeting. We have been fielding calls about carp in the outlet creek swimming upstream into the lake. We encourage anglers to safely harvest carp and hopefully find a good use for them, such as cooking them, smoking them, burying them in your garden, or bagging them and putting them out in the trash. Please do not leave them on the banks or roadside.

As we start to enjoy the summer activities around Lake Ripley please keep in mind that everyone has a different risk level for the Covid virus. Try to be careful around the boat landings, Ripley park, town pier and the preserve.

Save the Date: June 28 for Results of Public Opinion Survey & Chances to Engage Further

The District's public opinion survey results are in and highlights will be shared at a public meeting being held at 4 pm on June 28, at the Oakland Town Hall. All District members are invited to hear the results of the survey and offer reactions. If surveys aren't your thing, or COVID concerns keep you from attending, we offer two additional ways to engage.

Drop us a line with your email address, or phone with your physical address, and we'll send you a copy of the survey results, along with some questions we'll be asking at the live session. Write or call back with your thoughts. All responses, no matter what the format, will be recorded and used to quide the District in the update to the Ten Year Improvement Plan.

If there is enough interest, we also will set up a Zoom (computer-aided) meeting for a virtual live discussion of the survey results and to hear your thoughts. Please contact the Lake Manager by June 20th if this is an option you'd like to take advantage of. If even one district resident is interested, we'll set up a time, and meet over the computer. The District would like to remove barriers that may prevent us from hearing from you.

Our website, created in 2010, is ready for a new look and improved performance. We are in the process of spiffing it up, and are taking suggestions for things that you turn to our website to find and things you wish were there. How do you use the website? When is the last time you visited and for what? All suggestions, comments, and complaints welcome yes, even complaints – as we will be working to make improvements over the next several months.

Swimmer's Itch

Swimmer's itch is a temporary skin infection acquired by some lake swimmers when they accidentally become involved in the life cycle of microscopic parasites called schistosome. The larva of these parasites penetrate the skin and may cause alleraic reactions.

The parasites are found in shallow water near the shoreline. Snails are a common host during its life cycle, but other creatures, such as grackles, ducks, muskrat and moles can also be carriers.

Severity of the outbreak varies between humans, with children often more susceptible. To reduce risks, towel down immediately upon leaving the water, avoid areas where snails have accumulated, and when possible, swim in water away from the shore.

If Only I Had Help, I'd . . .

One standout revelation from compiling the results of our Public Opinion Survey was that many residents are unfamiliar with our District Cost-Share Program. This program, funded by the District, shares the cost with landowners for landscaping projects that benefit water quality in Lake Ripley. These efforts can range from major shoreline stabilization projects to rain gardens that capture run-off before it reaches the lake. If you are considering a project that would benefit the whole lake, and would like us to "share the cost" with you, please call the District office at 608-423-4537. Boat Safety Checks

Oakland Town Water Police inspect any vessel free of charge to ensure the vessel is up to WDNR Boating standards. No fines are issued during voluntary inspections. If interested, contact the police department at 608-423-7415 to make an appointment with an officer.

Assess, Monitor, Evaluate, Repeat

You will be seeing a lot of our little red motor boat this summer! Scientists funded through our DNR Large-Scale Planning Grant will be conducting five special surveys on the lake.

Summer Science at the District

In mid-June, there will be a plant survey to assess the growth of curly-leaf pondweed, a nonnative invasive species that can become a problem in early summer. We monitor it and the development of other lake plants, to determine when to start weed harvesting.

In late June researchers will be conducting a near-shore, non-game fish survey. Results of the findings will let us know how well Lake Ripley is able to support the species of fish that are important parts of the lake food web.

In July comes a shoreland and shallows survey. District staff in canoes or our small boat will be following DNR protocol to assess the lake buffer, bank, and "shallows" – or littoral zone. Data that is being collected will help us identify areas for protection or restoration, assist in making our aquatic plant management decisions, and evaluate trends in lakeshore habitat and lake ecolo- Dwight Osmon, MS, Environmental Science with an av over time.

In August, we will perform a late-season survey to catch the plants that need warmer water temperatures to grow and were not in evidence in June. Most aquatic plants are warm-season plants. Comparing the results of these surveys with earlier year surveys has direct bearing on the weed harvesting program permit application we submit to the DNR every five years.

In addition to these surveys, there will be a multimonth recreational boat-user study to augment the information we track in our yearly docked boat and pier count – due in July. Knowing how and when the lake is being enjoyed by people matters for safety and policy decisions.

We will do our best to post on our website and in social media when these surveys are occurring. Weather no doubt will adjust our plans! Please know that safeguards in response to COVID-19 will be in place.
