ORDINANCE NO. 2022-02 -

AN ORDINANCE TO DESIGNATE STOP SIGN PLACEMENT
AND TO ESTABLISH SPEED LIMITS

WITHIN THE TOWN OF CHARLESTOWN

The Town Board of the Town of Charlestown, Calumet County, Wisconsin, do ordain as follows:

Ordinance No 93-1 is repealed and recreated as follows.

1. Designation of Official Stop Sign and Traffic Control Intersections. The following intersections located within the Town of Charlestown, Calumet County, Wisconsin, are designated for the location of official stop signs. Every operator of a motor vehicle approaching an official stop sign as designated herein shall stop in the manner prescribed by Section 346.46, Wis. Stat. Stop signs shall be erected at the following locations:

1.1 on Bancroft Road at the intersection with Weeks Road, approaching from the west on Bancroft Road.

1.2 On Weeks Road at the intersection with Steiner Road, approaching from the south on Weeks Road.

1.3 On Spetta Road at the intersection with Lime Kiln Road, approaching from the south on Spetta Road.

1.4 On Meggars Road at the intersection with Stahl Road, approaching from the south on Meggars Road.

1.5 On Maple Heights Drive at the intersection with Debra Court, approaching from the east on Maple Heights Drive.

1.6 On Maple Heights Drive at the intersection with Debra Court, approaching from the west on Maple Heights Drive, provided, that no stop shall be required for a right turn (to the south) from Maple Heights Drive onto Debra Court.

1.7 On Peik Road at the intersection with Irish Road, approaching from the west on Peik Road.

1.8 On Steiner Road at the intersection with Irish Road, approaching from the east on Steiner Road.

1.9 On Hickory Hills Road at the intersection with Irish Road, approaching from the west on Hickory Hills Road.

1.10 on Bancroft Road at the intersection with Irish Road, approaching from the east and west on Bancroft Road.

1.11 On North Mill Road at the intersection with Irish Road, approaching from the southeast on North Mill Road.

1.12 On Quarry Road at the intersection with Irish Road, approaching from the east on Quarry Road.

1.13 On Short Road at the intersection with Irish Road, approaching from the west on Short Road.

1.14 On Redwood Road at the intersection with Irish Road, approaching from the west on Redwood Road.

1.15 On Quarry Road at the intersection with south Mill Road, approaching from the east and west on Quarry Road.

1.16 On Lime Kiln Road at the intersection with South Mill Road, approaching from the east on Lime Kiln Road.

1.17 On Quarry Road at the intersection with Hayton Road, approaching from the west on Quarry Road.

1.18 On Lime Kiln Road at the intersection with Hayton Road, approaching from the east and west on Lime Kiln Road.

1.19 On Bruckner Road at the intersection with Hayton Road, approaching from the east on Bruckner Road.

1.20 On Bruckner Road at the intersection with Honeymoon Hill Road, approaching from the west on Bruckner Road.

1.21 on Danes Road at the intersection with Honeymoon Hill Road, approaching from the east on Danes Road.

1.22 On Center Street at the intersection with Weeks Road, approaching from the east on Center Street.

1.23 On Steiner Road at the intersection with CTH Y.

1.24 On Weeks Road at the intersection with CTH Y, approaching from the north on Weeks Road.

1.25 On Riverview Heights Drive at the intersection with CTH Y.

1.26 on Irish Road at the intersection with CTH Y.

1.27 On Aebischer Road at the intersection with CTH Y.

1.28 On Weeks Road at the intersection with CTH Y, approaching from the south on Weeks Road.

1.29 On Quarry Road at the intersection with CTH T.

1.30 On Hayton Road at the intersection with CTH T.

1.31 On Danes Road at the intersection with CTH T.

1.32 On Stahl Road at the intersection with CTH T.

1.33 On Honeymoon Hill road at the intersection with CTH T.

1.34 On Buhl Road at the intersection with CTH T, approaching from the north on Buhl Road.

1.35 On Buhl Road at the intersection with CTH T, approaching from the east on Buhl Road.

1.36 On Church Road at the intersection with CTH T.

1.37 On North Mill Road at the intersection with Wisconsin Highway 151.

1.38 On Weeks Road at the intersection with Wisconsin Highway 151.

1.39 On Washington Street at the intersection with Wisconsin Highway 151.

1.40 On Church Road at the intersection with Wisconsin Highway 151.

1.41 On Geiser Road at the intersection with Wisconsin Highway 151.

1.42 On Lemke Road at the intersection with Wisconsin Highway 151.

1.43 On south Mill Road at the intersection with Wisconsin Highway 151.

1.44 On Irish Road at the intersection with Wisconsin Highway 151.

1.45 On Quarry Road at the intersection with Wisconsin Highway 57, approaching from the east and west on Quarry Road.

1.46 On Irish Road at the intersection with Wisconsin Highway 57, approaching from the north and south on Irish Road.

1.47 On Maple Heights Drive at the intersection with Wisconsin Highway 57.

1.48 On Redwood Road at the intersection with Wisconsin Highway 57.

1.49 On South Mill Road at the intersection with Wisconsin Highway 57.

1.50 On Shady Lane at the intersection with Wisconsin Highway 57.

2. Designation of yield signs. On the following town roads at the intersection of the road with the Wisconsin Central Limited Railroad track which runs in a generally southeast to northwest direction in the Town of Charlestown, yield signs shall be erected:

- A. South Mill Road, from the north and south.
- B. Quarry Road, from the east and west.
- C. Lime Kiln Road, from the east and west.
- D. Hayton Road, from the north and south.
- E. Bruckner Road, from the east and west.

3. Speed Restrictions. The speed limit for vehicular traffic for the following town highways located within the Town of Charlestown is established at thirty-five (35) miles per hour. No person shall operate a motor vehicle in excess of thirty-five (35) miles per hour on the following town highways:

3.1 Hayton Area

(a) That portion of Weeks Road lying north of Highway 151, commencing at Highway 151 and proceeding in a northerly direction for a distance of three-tenths (.3) of a mile.

(b) Center Street.

(c) Washington street.

3.2 Shady Lane Area

(a) Shady Lane Drive.

3.3 Maple Heights Area

(a) Maple Heights Drive - Debra Court.

3.4 Riverview Heights Area

(a) Riverview Heights Drive.

(b) Riverview Heights Court.

4 Signage. The town chairperson or his designee is authorized and directed to install official stop signs and stop ahead signs and speed limit signs according to the requirements of the Wisconsin Statutes and Wisconsin Administrative Code, and consistent with the terms of this ordinance, and subject to the prior duty and authority of Calumet County to install official stop signs as set forth in the applicable County Ordinances, Wisconsin Statutes, and Wisconsin Administrative Code.

5 Incorporation of Wisconsin statutes. The provisions of Chapters 340, 345, 346, and 349, Wis. Stats., including all future amendments, modifications, revisions, additions or deletions, are hereby adopted and incorporated herein by reference as if fully set forth herein.

6 Penalty. The penalty for violation of Section 1 of this ordinance shall be a forfeiture as set forth in Section 346.49, Wis. Stat., together with the costs of prosecution. The penalty for violation of Section 2 of this ordinance shall be a forfeiture as set forth in Section 346.60(2), Wis. Stats., together with the costs of prosecution.

7 Severability. The provisions of this ordinance shall be severable. In the event any portion of this ordinance is determined to be unconstitutional, invalid, or unenforceable by a court of competent jurisdiction, such determination shall not affect the remainder of this ordinance. The Town Board hereby declares its intent to have passed all other provisions of this ordinance, and the remainder of the ordinance shall not be affected by such determination.

8 Terms of Addition; Repeal of Conflicting Ordinances. The terms of this ordinance are in addition to, and not in replacement of, all prior ordinances regulating official stop sign designations and speed restrictions in the Town of Charlestown. If any provision hereof is in conflict with a provision of existing ordinances of the Town of Charlestown, said existing ordinance, to the extent of the conflict, is hereby repealed, and this ordinance shall prevail.

9 Effective Date. This ordinance shall take effect and be in force from and after its passage and posting according to law.
