TAX PAYMENTS

Please MAIL 1st Installment or Full Property Tax Payments to the Town Treasurer on or before January 31st. Address is: 185544 Birnamwood Road. Birnamwood, WI 54414. Detach the bottom portion of your property tax bill and include with your payment. A receipt will be returned to you upon request. We can email your receipt if email is provided. If you pay your taxes with an escrow check and are due a refund, refund checks will be sent to the property owner. You are responsible for ensuring the tax amount paid, especially escrow checks, meets the minimum due and is received by the Town Treasurer on or before January 31, 2026.

Late or Second Installments are due July 31, 2026. They must be paid to the County Treasurer and sent to the Wausau Address.

Dog Licenses

WI statute 174.05 requires all dogs be licensed annually and be vaccinated for rabies. Dog licenses can be paid anytime before **APRIL 1st** or upon a new acquisition.

You must enclose a current Rabies Vaccination Certificate as proof with your payment, no invoices please.

Illegal Dumping

Dumping of leaves, grass, brush, trash, excess dirt, etc. in ditches and vacant property (w/o owner's express permission) is prohibited.

Make sure your trees are trimmed in your driveway for access by emergency vehicles. Some of them are rather large and it can be difficult for them to get through to help you.

Wisconsin state law requires vehicles to stay back from a working snowplow at least: 200 feet on a road with a posted speed limit more than 35 mph & 75 feet on a road posted with a speed limit under 35 mph

Hillcrest Cemetery

The Hillcrest Cemetery is located on Norrie Road and is a non-denominational final resting place. Please refer to the town website for rules and regulations, contact information and costs including burial procedures. The Association meets annually on the 1st Saturday of April.

The annual cemetery meeting will be held Saturday, April 4, 2026 at 10 a.m. at the Norrie Town Hall.

BUILDING PERMITS REQUIRED

The Town of Norrie requires a building permit on all construction and remodeling with a value of \$5,000 or more. Permits must be obtained from the Town before the work can begin. Applicants are required to attend the town meeting with a drawing displaying building measurements, lot lines, etc. The Town also requires new houses be inspected upon completion. Please call Mike Block, Building Inspector, at 715-490-4069 after you have your town permit but before construction begins. Please remember the Township has a minimum lot size of 2 acres for a new residence.

Non-Refundable Building permit fee is \$300.

Town Hall Rental

If you wish to rent the Norrie Town Hall, please call Carla Georgi at 715-432-5036 to reserve the hall. Town residents are given a discounted rate.

Lottery Tax Credit

It you are a WI resident, own a dwelling and used it as a primary dwelling on January 1, 2025, you may qualify for a lottery tax credit. Please check your tax bill for this credit. If you believe you qualify, you must contact the town treasurer by 1/31/26 for the calculation. After 1/31/26, you must file with the Department of Revenue.

Please keep your address sign visible for emergency vehicles

State statute 86.04 addresses Right of Way encroachments. Plantings, crops, vegetation, fences, buildings, or any other structure or object within the road right of way has the potential to create a safety hazard, may make it difficult for the town to perform routine road maintenance and may interfere with existing utilities and/or traffic control devices. The Town of Norrie will take action to correct such obstructions. This may be at the property owners expense. For reference, the right of way on a 4 rod road is 33' from the centerline. The townshipi will also enforce Wisconsin Statute 86.01 and 346.94 prohibiting the pushing of snow and other materials onto or across the roadway or into the public right of way from side roads and driveways. Cleanup of materials, including snow, in the roadway will also be at property owner's expense. When road workers are working, please give them room to do their tasks safely.
