ORDINANCE NO. 17 - 6

AN ORDINANCE TO AMEND THE MUNICIPAL CODE TO UPDATE THE PROVISIONS PERTAINING TO TATTOO AND BODY PIERCING ESTABLISHMENTS TO PROVIDE FOR CONSISTENCY WITH CURRENT AND BEST PRACTICES AND THE REGULATIONS ADMINISTERED BY THE STATE OF WISCONSIN DEPARTMENT OF SAFETY AND PROFESSIONAL SERVICES

WHEREAS, the Village Health Department has become an agent for the Wisconsin Department of Safety and Professional Services to administer the tattoo and body piercing establishments program; and

WHEREAS, revision of the Municipal Code is necessary to be consistent with current and best practices and with the provisions of the Wisconsin Statutes and the Wisconsin Administrative Code as they pertain to the regulation of tattoo and body piercing establishments; and

WHEREAS, the Village Board having reviewed the proposed amendments to the Municipal Code, specifically, amendments to certain provisions of §14.22 <u>TATTOO AND BODY PIERCING ESTABLISHMENTS</u>, and having determined that they are reasonable and necessary to protect and promote the health, safety and welfare of the Village.

NOW, THEREFORE, the Village Board of the Village of Hales Corners, Wisconsin, do ordain as follows:

SECTION 1:

§14.22(1) of the Municipal Code of Hales Corners, Wisconsin, is hereby amended to read as follows: delete: "252.23 to 252.245", and in place thereof, insert: "§463.10 to 463.18"; and delete: "§252.245(6)", and in place thereof, insert: "Chapter 463".

SECTION 2:

§14.22(3)(a) of the Municipal Code of Hales Corners, Wisconsin, is hereby amended to read as follows: delete: "State of Wisconsin Department of Health and Family Services", and in place thereof, insert: "the Village of Hales Corners".

SECTION 3:

§14.22(6) of the Municipal Code of Hales Corners, Wisconsin, is hereby amended to read as follows:

Fees. The following fees shall be assessed all applicants:

- (a) The fees for services and activities performed by the Department in carrying out its responsibilities under this Code shall be published in the Village of Hales Corners Health Department Fee Schedule;
- (b) License fees shall accompany the license application;
- (c) There will be no proration of license fees, with the exception of requirements for agent status;
- (d) No license fee paid shall be refunded unless the license is denied;
- (e) Local pre-inspection fees shall be charged and shall include all inspection-related activities prior to the establishment doing business. Pre-inspection fees may be applicable for all new operations, changes in operation, remodeling or extension. Pre-inspection fees are not refundable; and
- (f) Failure to correct a violation that requires a second follow-up inspection and any subsequent re-inspections shall require a re-inspection fee.

SECTION 4:

§14.22(7) of the Municipal Code of Hales Corners, Wisconsin, is hereby amended to read as follows:

License Year.

- (a) All licenses granted under this chapter shall expire on June 30 and must be renewed.
- (b) Renewal notices shall be furnished by the Department prior to the expiration date.
- (c) It is the responsibility of the licensee to complete the application form and pay the appropriate fee before the expiration date.

SECTION 5:

§14.22(10) of the Municipal Code of Hales Corners, Wisconsin, is hereby amended to read as follows: delete: "Health and Family Services", and in place thereof, insert: "Safety and Professional Services".

SECTION 6:

§14.22(12) of the Municipal Code of Hales Corners, Wisconsin, is hereby amended to read as follows: delete: "HFS 173.11", and in place thereof, insert: "§SPS 221.16".

SECTION 7:

§14.22(14) of the Municipal Code of Hales Corners, Wisconsin, is hereby amended to read as follows: delete: "HFS 173.03(20)", and in place thereof, insert: "§SPS 221.14".
