Candidates for Justice of the Supreme Court, Court of Appeals, and Circuit Court file nomination papers and declarations of candidacy with the Wisconsin Elections Commission. Candidates for County Supervisor file documents with the Milwaukee County Election Commission.

Primary Election

If a primary is necessary, the primary will be held on Tuesday, February 17, 2026.
