# REDUCE - REUSE - RECYCLE 2026

## REFUSE COLLECTION

Waste collection in the village is weekly automated pick-up of 95-gallon carts on scheduled days. All materials eligible for refuse collection must be placed in the cart. Any material ***left outside or next to the cart will not*** be collected. Place cart curbside or within seven feet of pavement edge by 6:00 am, but no sooner than noon of the previous day. Emptied carts shall be removed by 8:00 am the day following collection. GFL Environmental will also take larger household items, up to 200 pounds. **Please call GFL Environmental directly (262) 679-0860 to arrange pickup of items such as appliances, furniture, mattresses, carpet, etc. There is no additional charge for this service.**

***To report a missed pickup or request a special pickup do not call Village Hall. Report these instances directly to GFL Environmental. Call (262) 679-0860 or use the website [www.gflenv.com](http://www.gflenv.com).***

## RECYCLING

Recycling collection in the village is bi-weekly with automated pick-up of 95-gallon carts. All materials eligible for recycling must be placed in the cart and any material ***left outside or next to the recycling cart will not*** be collected. There is no need to separate recycling materials, just put them all in the cart. For more information visit [www.gflenv.com](http://www.gflenv.com) or call (262) 679-0860. GFL Environmental has exclusive control over recyclables placed curbside under Village Ordinance and scavengers will be prosecuted under Chapter 370 Article III of the Village Code.

### **Recycle:**

Plastics #1 through #7  
Glass bottles and jars  
Tin, bi-metal and aluminum cans  
Newspaper & miscellaneous household paper  
Magazines & phone books  
Cardboard (cut to fit into container)  
Foam PS (polystyrene) packaging  
Aseptic containers  
*Rinse all bottles & cans and remove lids.*

### **DO NOT recycle:**

plastic bags  
aluminum foil  
packing material  
motor oil containers  
frozen food boxes and any other paper product that has been soiled with food, such as used paper plates or pizza boxes.

## YARD WASTE/FALL LEAF PICKUP

Yard Waste shall be contained in sturdy paper bags, cardboard boxes, or containers to be collected on scheduled days. The volume shall not exceed thirty-two (32) gallons of capacity or fifty (50) pounds of weight. If a resident desires a Yard Waste container returned, they shall legibly write "SAVE" on said container. Large branches and logs may be stacked curbside but shall not exceed six (6) inches in diameter or four (4) feet in length. Small branches, logs, or brush shall be bundled and tied with string. Bundle diameter shall not exceed one (1) foot in diameter or exceed four (4) feet in length, or exceed fifty (50) pounds in weight. **Each household shall be limited to six (6) bags/containers/bundles per collection.** During the last five (5) collections of the year, each household shall be limited to ten (10) bags/containers/bundles. **Plastic bags are allowed during the last five (5) collections only.** Individual plastic bags may not exceed fifty-five (55) gallons in capacity or fifty (50) pounds. Additionally, GFL provides access to all Hales Corners household residents to the GFL Yard Waste Drop-off Site at W144S6350 College Court, Muskego, WI 53150 on Saturdays 7am-2pm (WEATHER PERMITTING. If no truck is there, a roll-off container will be provided. Requirements for bundles still apply to dropped off yard waste.) There is no limit to the number of containers, bags, stacks, or bundles at the Yard Waste Drop-off site. Proof of residency is required.
