# Emerald Ash Borer (EAB)





#### What is EAB?


- EAB is an invasive insect discovered in the USA in 2002.
- EAB infests Ash trees which are common in residential and forest areas in New Jersey.1
- EAB larvae cut off the water supply and causes trees to become dry and brittle.

#### What are the signs of EAB?


- Infested trees will experience canopy dieback, if not treated, this will eventually affect the entire tree.
- Other identifiers are: bark flecking, woodpecker marks, D-shaped exit holes in bark and excessive sprouting from the lower trunk of tree.




Canopy Dieback

# Infested Trees are Dangerous

- If you have infested Ash trees on your property, they could pose a safety risk to your family, your home and your neighbor's property.
- Infested Ash trees become dry and brittle, therefore branches will break more easily than a healthy tree branch.





- Little to no stress on branches of infested trees will cause them to snap or shatter.
- Never allow children to play in or near an Ash tree that is showing symptoms of being infested by EAB.

# Millstone Alliance to Prevent Substance Abuse

#### SPORTS INJURIES AND PAINKILLERS - WHAT PARENTS SHOULD KNOW

It always starts off simply – a foot injury, a twisted knee, a broken arm and a prescription to ease the pain. Add to this anger, depression and the humiliation of a game lost and there is the perfect combination of physical and mental pain that can be treated simply with the numbing effect of prescription medication like oxycodon, percocet, vicodin or any other number of addictive opioid medications. Kids know that pills are so easy to get after their prescription runs out– from parents' medicine cabinets, grandma's pill box, or a "friend" who always gets the best stuff. And then they are in the grip of opioids.

Opioid misuse cuts across all demographics – young, old, male, female, wealthy, indigent rural, urban and most of all suburban. But what has public health authorities and law enforcement concerned is a growing concentration in an unlikely subset of users – young athletes. Prevention and enforcement agencies are seeing that high school athletes are ready targets for use and abuse of prescription drugs. The number of athletes with opioid misuse disorders and who have become victims of overdose is significantly on the rise. And it cuts across all sports and athletic pursuits, acording to a recent investigative report – baseball, basketball, football, golf, gymnastics, swimming, wrestling – any activity that puts youth at risk for physical injury.

How does this happen? According to a study by the US Substance Abuse and Mental Health Services Administration, 80% of all users progress to heroin after abusing opioid painkillers. According to the National Institute of Drug Abuse, one in 15 people who take nonmedical prescription painkillers will try heroin within the next 10 years.

Then there is the nature of sports in America. Players face enormous pressure to win, be the best, get the sports scholarships and with that comes the mindset that they need to tough it out, play through an injury by managing pain – whatever it takes. A recent Sports Illustrated article indicated that sports that involve high levels of risk and contact, tend to socialize youth to view pain and physical violence as just a normal part of the sport, and this can infuence risky behavior both on and off of the playing field. This article reported on a local Monmouth County lacrosse player who was prescriped Roxicodone for a hand injury. He became addicted to the medication. With a future scholarship on the line, he rationalized that playing high was better than not playing at all – "us athletes, we'll do anything to keep playing." Progressing to heroin, his main focus now became travelling to Newark to get his heroin fix, and college lacrosse became the least of his concerns. As the mother of one athlete who lost his life to a heroin overdose shared, "My son knew he was meant to be an athlete. Sports was his first addiction. He just ran into another one that was so much more powerful."

So what is being done to protect our athletes? Recently the NJ Department of Education created an educational fact sheet that provides information regarding prescribing of medication for sports-related injuries. All student-athletes and cheerleaders participating in an interscholastic sports program (or their parents if they are under 18) must provide written acknowledgement of their receipt of the fact sheet. Also, with the start of the next school year, there is an educational video that is mandated to be viewed. This is a start, but it doesn't cover every child who pursues sports – cetainly not the kids who are playing a game of touch football in backyards all over town. So parents need to educate themselves about the dangers of misuse of opioids, signs, symptoms and resources.

Better yet, attend our meetings, held the second Thursday of each month at 7:00 PM in the Court Building at 215 Millstone Road. An educated parent is the best source of protection for our kids.
