




Carried Application: Z18-10 Noreika, Charles - Block 50, Lots. 1.01, 1.02, 1.03 & 2, Route 524 Scooter Corner, consisting of 28+ acres in the R-80 zoning district. Applicant seeks Preliminary and Final Major Subdivision Approval, Preliminary and Final Site Plan Approval and Use Variance Approval for the property commonly known as Rte 524 Scooter Corner, also known as Block 50, Lots 1.01, 1.02, 1.03 and 2 on the tax map of Millstone Twp. The applicant proposes to create 11 lots. 8 lots will contain new residential lots, 1 lot will be designated for stormwater management, 1 lot will contain the existing single family home and 1 lot will be for the commercial use.

The applicant proposes to continue the retail and sales commercial use and buildings on the commercial lot and to construct a new 3,600 s.f. commercial building with a 2 bedroom apartment on the second floor and a four car garage in the basement on the commercial lot. The applicant also proposes to construct a 1,900 s.f. addition to the existing 4,900 s.f. barn. The applicant requires a Use Variance for the commercial use, as it is not permitted in the R-80 Zone. The applicant also requires a lot coverage variance of 26.3%, where the maximum of 20% is permitted on the proposed commercial lot.

The applicant also requires a front yard setback variance of 45.6 feet, where a minimum of 50 ft. is required for the existing home and a side yard setback of 8.2 feet, where 15 feet is required for the existing shed. These variances relate the proposed lot that will contain the existing single family home. Deemed Complete 12-7-18. Date of Action: 4-6-19. Noticing Required. Application approved with conditions.





SPOTTED LANTERNFLY BACKGROUND



Detected on September 22, 2014 in Berks County Pennsylvania, (SLF) is a plant Hopper. Makes use of over 70 different plant species, including fruit trees, ornamental tree, woody trees, vegetable herb, and vines, including agriculture crops such as grapes and hops.

- Damage:** Like most hemipterans, SLF feeds on plants using their sucking and piercing mouthparts to extract plant sap.
- Adults and nymphs feed on phloem tissues of young stems with their piercing and sucking mouthparts and excrete large quantities of liquid (honeydew)
 - Feeding creates weeping wounds
 - Honeydew facilitates the growth and sooty mold

What to do: If you see egg masses, scrape them off, double bag them and throw them away. You can also place the eggs into alcohol, bleach or hand sanitizer to kill them.

Collect specimen: Specimens in any life stage can be turned in to the New Jersey Department of Agriculture lab for verification.

Take a picture: With your GPS function turned on your smartphone or a camera with GPS, take a photo of any life stage (including egg masses). Submit a picture to: SLF-plantindustry@ag.nj.gov.

Report a site: If you can't take a specimen or photograph call New Jersey Spotted Lanternfly Hotline at 1-833-233-2840 (BADBUGO) and leave a message detailing your sighting and contact information.

The Millstone Township Fire Department routinely responds to motor vehicle accidents on many of the roadways in the Township that you or your family, may travel on a daily basis. In fact, in 2018, motor vehicle accidents made up almost 17% of our yearly call volume. Here are a few safety tips to remember.

Distracted Driving

Distracted driving is any activity that diverts attention from driving, including talking or texting on your phone, eating and drinking, talking to people in your vehicle, fiddling with the stereo, entertainment or navigation system—anything that takes your attention away from the task of safe driving. Texting is the most alarming distraction. Sending or reading a text takes your eyes off the road for 5 seconds. At 55 mph, that's like driving the length of an entire football field with your eyes closed. You cannot drive safely unless the task of driving has your full attention. Any non-driving activity you engage in is a potential distraction and increases your risk of crashing.

Dangers of Speeding

For more than two decades, speeding has been involved in approximately one-third of all motor vehicle fatalities. In 2017, speeding was a contributing factor in 26 percent of all traffic fatalities. Speed also affects your safety even when you are driving at the speed limit but too fast for road conditions, such as during bad weather, when a road is under repair or in an area at night that isn't well lit. Speeding is a type of aggressive driving behavior. Several factors have contributed to an overall rise in aggressive driving:

Traffic: Traffic congestion is one of the most frequently mentioned contributing factors to aggressive driving, such as speeding. Drivers may respond by using aggressive driving behaviors, including speeding, changing lanes frequently, or becoming angry at anyone who they believe impedes their progress.

Running Late: Some people drive aggressively because they have too much to do and are "running late" for work, school, their next meeting, lesson, soccer game, or other appointment.

Anonymity: A motor vehicle insulates the driver from the world. Shielded from the outside environment, a driver can develop a sense of detachment, as if an observer of their surroundings, rather than a participant. This can lead to some people feeling less constrained in their behavior when they cannot be seen by others and/or when it is unlikely that they will ever again see those who witness their behavior.

Disregard for Others and for the Law: Most motorists rarely drive aggressively, and some never do. For others, episodes of aggressive driving are frequent, and for a small proportion of motorists it is their usual driving behavior. Occasional episodes of aggressive driving—such as speeding and changing lanes abruptly—might occur in response to specific situations, like when the driver is late for an important appointment, but is not the driver's normal behavior.

If it seems that there are more cases of rude and outrageous behavior on the road now than in the past, the observation is correct—if for no other reason than there are more drivers driving more miles on the same roads than ever before.

Impaired Driving

Driving after drinking is deadly. Yet it still continues to happen across the United States. If you drive while impaired, you could get arrested or worse—be involved in a traffic crash that causes serious injury or death. Before drinking, choose a non-drinking friend as a designated driver.

Don't let your friends drive impaired.

If you have been drinking, call a taxi, a ride sharing service, or a sober friend.

If you're hosting a party where alcohol will be served, make sure all guests leave with a sober driver.

Always wear your seat belt—it's your best defense against impaired drivers.

Deer

It should be of no surprise to any long time Millstone resident that collisions commonly occur due to striking deer or attempting to avoid striking deer. Here are a few tips to remember.

Watch for the rest of the gang. Deer are pack animals, and rarely travel alone. If a deer crosses in front of you, chances are there are more nearby. Slow down and keep an eye out for more deer darting across the road.

Timing is everything. Deer are most active at dusk and dawn: periods when your vision is most compromised. To add to their terrible timing, deer are on the move during mating season (between October and January) when you're more likely to travel after the sun sets. Slow down and stay alert, especially after dark.

Wear your seat belt. It may not prevent a collision, but if the inevitable happens a seat belt can reduce injuries. This is especially true if you lose control and collide with something bigger, and more stationary than a deer.

Take a moment to reflect. First, look for the road signs. The yellow diamonds with the deer on it are placed in high-traffic areas for deer. You may also spot a deer because their eyes will brightly reflect a car's headlights, making them easier to spot.

Stay Center. On a multi-lane road, the center lane is your safest bet for avoiding a deer collision, as long as your local traffic laws permit it. This gives deer plenty of space; and in case your vehicle does startle them, it gives you more time to react if one darts onto the road.

Stay the course. If you see a deer, brake firmly and calmly, and stay in your lane. Swerving could make you lose control of your vehicle and turn a bad situation much worse. Not to mention, deer are unpredictable, and you could swerve directly into their changed path.

Honk! Some experts recommend that one long blast of the horn will scare deer out of the road. Do not rely on hood whistles or other devices designed to scare off deer—studies have shown them to be largely ineffective at minimizing accidents.

Hopefully these safety reminders and tips will keep you and family safe during your daily travels.
