AN ORDINANCE AMENDING CHAPTER V (FEES),
SECTION 5-2 (FEES FOR CHAPTER II: ADMINISTRATION), PARAGRAPH C
(RECREATION REGISTRATION) OF THE REVISED GENERAL ORDINANCES OF THE
TOWNSHIP OF MILLSTONE, COUNTY OF MONMOUTH AND STATE OF NEW JERSEY

BE IT ORDAINED by the Township Committee of the Township of Millstone, County of Monmouth and State of New Jersey, as follows: (additions are underlined, and deletions are in [brackets])
