Group Park Usage – (fees below do not include field or court reservations)

- a. 1 – 50 people Residents - \$50/group/day Non-Residents - \$100/group/day
- b. 51 – 100 people Residents - \$100/group/day Non-Residents - \$200/group/day
- c. 101 Plus Residents- \$150/group/day Non-Residents - \$300/group/day

Additional Fee – A minimum of 2 designated township employees for a minimum of 4 hours at \$65 per hour, per employee for each facility location used.

EXPLANATORY STATEMENT: This ordinance sets fees for the use of township parks and facilities.
