CHAPTER XIV: BUILDING AND HOUSING), SUBSECTION 5-14.3 (STATE  
UNIFORM CONSTRUCTION CODE FEE), OF THE REVISED GENERAL  
ORDINANCES OF THE TOWNSHIP OF MILLSTONE, COUNTY OF MONMOUTH  
AND STATE OF NEW JERSEY**

**BE IT ORDAINED** by the Township Committee of the Township of Millstone, County of Monmouth and State of New Jersey, as follows: additions are underlined, and deletions are in [brackets].

**I**

Chapter V (Fees), Section 5-14 (Fees for Chapter XIV: Building and Housing), Subsection 5-14.3 State Uniform Construction Code Fees, Building and Housing is hereby amended as follows:

5-14.3a.-f. No change

5-14.3g. Fire Protection Subcode Fee. The fire protection subcode permit fee shall be as described below:

1. The fire protection permit fee for smoke, carbon monoxide and heat detectors shall be as follows:

From 1 to 10 <del>detectors</del> <u>devices</u>	\$50
Over 10 <del>detectors</del> <u>devices</u>	\$50 plus \$5 for each addition <del>detectors</del> <u>devices</u>

2. No change

3. The fire protection permit fee for wet or dry sprinkler heads shall be as follows:

From 1 to 20 heads	<del>\$50</del> <u>\$100</u>
From 21 to 100 heads	<del>\$80</del> <u>\$140</u>
From 101 to 200 heads	<del>\$140</del> <u>\$300</u>
From 201 to 400 heads	<del>\$300</del> <u>\$500</u>
From 401 to 1,000 heads	<del>\$500</del> <u>\$700</u>
Over 1,000 heads	<del>\$700</del> <u>\$900</u>

**EXPLANATORY STATEMENT:** This Ordinance amends the fire protection subcode fee as per state and provides the fees to be applied for permits obtained under Chapter XIV, Building and Housing.
