SECTION 5-2 (FEES FOR CHAPTER II: ADMINISTRATION), PARAGRAPH C (RECREATION  
REGISTRATION) OF THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF  
MILLSTONE, COUNTY OF MONMOUTH AND STATE OF NEW JERSEY

**BE IT ORDAINED** by the Township Committee of the Township of Millstone, County of Monmouth and State of New Jersey, as follows: (additions are underlined, and deletions are in [~~brackets~~]).

**I**

Chapter V, Fees, Section 5-2, Fees for Chapter II Administration, paragraph c., Recreation Registration, is hereby amended to read as follows:

**c. Recreation Registration.**

1. – 37. No change.

38. Spring Youth Baseball and Softball

<u>a. T-Ball (4-5 year old boys &amp; girls)</u>	<u>\$10 per person</u>
<u>b. Coach Pitch (5-6 year old boys &amp; girls)</u>	<u>\$150 per person</u>
<u>c. Rookies (7-8 year old boys &amp; girls)</u>	<u>\$200 per person</u>
<u>d. Minors (9-10 year old boys &amp; girls)</u>	<u>\$200 per person</u>
<u>e. Majors (11-12 year old boys &amp; girls)</u>	<u>\$225 per person</u>
<u>f. Babe Ruth Baseball (13-18 year old players)</u>	<u>\$250 per person</u>
<u>g. 6U Softball</u>	<u>\$50 per person</u>
<u>h. 8U Softball</u>	<u>\$200 per person</u>
<u>i. 10U Softball</u>	<u>\$200 per person</u>
<u>j. 12U Softball</u>	<u>\$225 per person</u>
<u>k. Babe Ruth Softball (14U, 16U, 18U girls)</u>	<u>\$250 per person</u>

**II**

The remainder of Section 5-2, paragraph c., concerning Recreation Registration fees shall remain unchanged.

**III**

All Ordinances and parts of Ordinances inconsistent herewith are hereby repealed.

#### **IV**

If any section, subparagraph, sentence, clause or phrase of this Ordinance shall be held to be invalid, such decision shall not invalidate the remaining portion of this Ordinance.

#### **V**

This Ordinance shall take effect upon adoption and publication according to law.

**EXPLANATORY STATEMENT:** This Ordinance amends the Recreation Registration fees contained in Chapter V, Section 5-2, paragraph c. of the Revised General Ordinances of the Township of Millstone.
