HIGHLIGHTS FROM THE TOWNSHIP CLERK'S OFFICE:

2026 DOG LICENSES: All dogs 7 months or older are to be licensed each year. Did you know you can register and pay for your dog licenses online? [Click here](#) or visit eforms-main.govpilot.com/NJ/millstonetownship, scroll down to Clerk and select Dog License Application. You can only renew from a desktop/laptop computer or ipad. If you have licensed in the past year, you will receive a renewal email only. You can also purchased a 2026 Dog License at the Municipal Building between 8:30 a.m. and 4:00 p.m. Monday through Friday in the Municipal Clerk's Office, Room 105 starting January 2, 2026. The rabies vaccination must be valid through October 31, 2026 and is required to be uploaded using the online portal or shown in person along with proof of spay/neuter. Neutered/Spayed dog fee is \$12.00 and Non-Neutered/Non-Spayed dog fee is \$15.00.

A late fee of \$10.00 PER DOG goes into effect May 1, 2026 for the current year.

Millstone Alliance to Prevent Substance Misuse Partners in Prevention for 35 Years

Did you realize that this year marks the Alliance's 35th anniversary of serving Millstone residents? Millstone has been a part of the largest network of community-based prevention coalitions in the country for more than three decades. Alliances are established by municipal ordinance and work to engage all sectors of the community in efforts to promote healthy behaviors and prevent substance misuse.

The Alliance has been active since 1990, helping to raise awareness about signs and symptoms of substance use disorders and sharing this information through community publications, local events and school and community programs. For example, during this grant year youth programs include LifeSkills Training for all 5th graders, the Achievers' After School Homework Club will run on Wednesday afternoons, and anti-vaping programs are in place for all middle school students. For parents/caregivers, STEP (Systematic Training for Effective Parenting) and The Power of a Grandparent will be scheduled in the spring.

Everyone can play a role in prevention by making changes - big or small - that promote a healthy lifestyle at home and in the community. Small actions can make a big difference! You can start by attending an upcoming meeting to hear the latest information on the impact of substance misuse in our area and how to discuss these important issues with children. 12/18/25, 2/19/26, 4/16/26, 6/18/26

Official Notice: To Residents and Businesses of Millstone Township

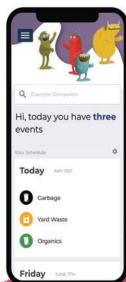
Recycling is mandated by the State, County and Municipal Statutes.

All residents will separate newspapers, glass bottles and jars, tin and bi-metal cans, plastic containers, aluminum cans, corrugated cardboard for collection and ultimate recycling of materials.

Curbside Recycling Guidelines:

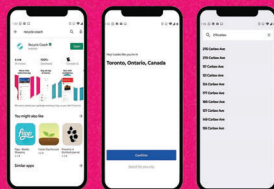
- Residential recycling is to be placed curbside on recycle days only before 6:00 AM. Recyclables should be placed loose in container 32 gallons or smaller. **Please do not place your recyclables in a plastic bag, as they will not be picked up.**

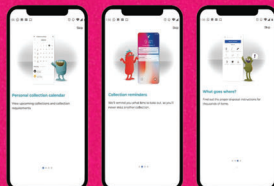

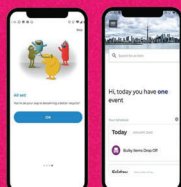

DID YOU KNOW?

Many times residents concerned with the environment want to recycle properly. However, items such as window glass, plastics that hold personal hygiene products, or other products that manufacturers print with the "recycling triangle", can't be recycled. Placing even a small amount of these items in our recyclables can cause the entire truck load to be rejected. When this occurs the truck is sent to the landfill and none of it is recycled. This is the leading reason recycling costs are going up.

MILLSTONE TOWNSHIP 2026 CURBSIDE SPRING CLEANUP **Monday, April 6 to April 10**

Maximum allowed per household 5'x 5'x 5' and should be placed curbside no later than 6AM on Monday, April 6, 2026.

- ❖ Hauler will have up to 4-17-26 to complete cleanup, however hauler will only do one pass on each road.

NO COMMERCIAL CONTRACTORS OR BUILDERS

Items that will NOT be picked up:

- ❖ Appliances: refrigerators, freezers, washing machines, dryers etc.
- ❖ Individual Items weighing over 100 Lbs. at the discretion of the vendor.
- ❖ Rocks, stones, leaves, logs, brush, grass, slate, concrete, etc.
- ❖ Electronic devices of any type.
 - Currently electronics may be dropped off at the Millstone Twp. Recycling Yard or at the Monmouth County Reclamation Center, 6000 Asbury Ave, Tinton Falls NJ 07724. 732-683-8686
- ❖ Motor vehicles or motor vehicle parts.
- ❖ Tires, wheels, gas or propane tanks, water softener tanks, hot water heaters.
- ❖ Treated wood or painted wood (hazardous material).
- ❖ Non-hazardous wood must be 4' or less in length without nails, screws or staples.
- ❖ Metal pipes or barrels.
- ❖ Recyclables, hazardous material or liquid waste.
- ❖ Construction material.
- ❖ **Anything in non-transparent plastic bags. Clear bags only.**
- ❖ Hazardous materials may be taken to the Monmouth County Reclamation Center by appointment. 732-683-8686.
