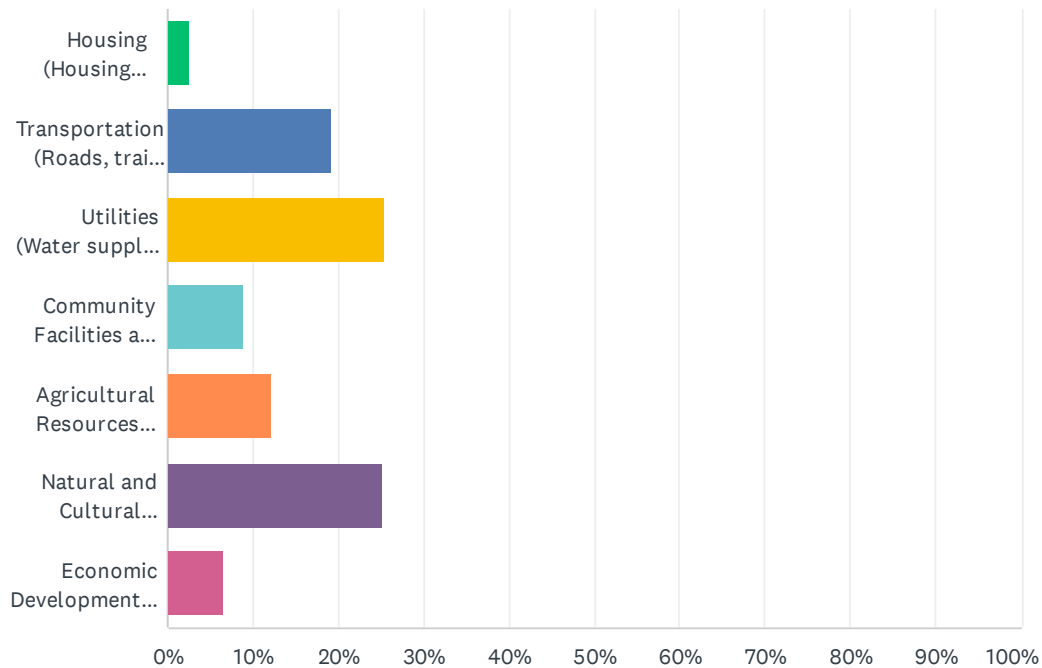


Q1 What is the most important topic for the Town? (Select one)

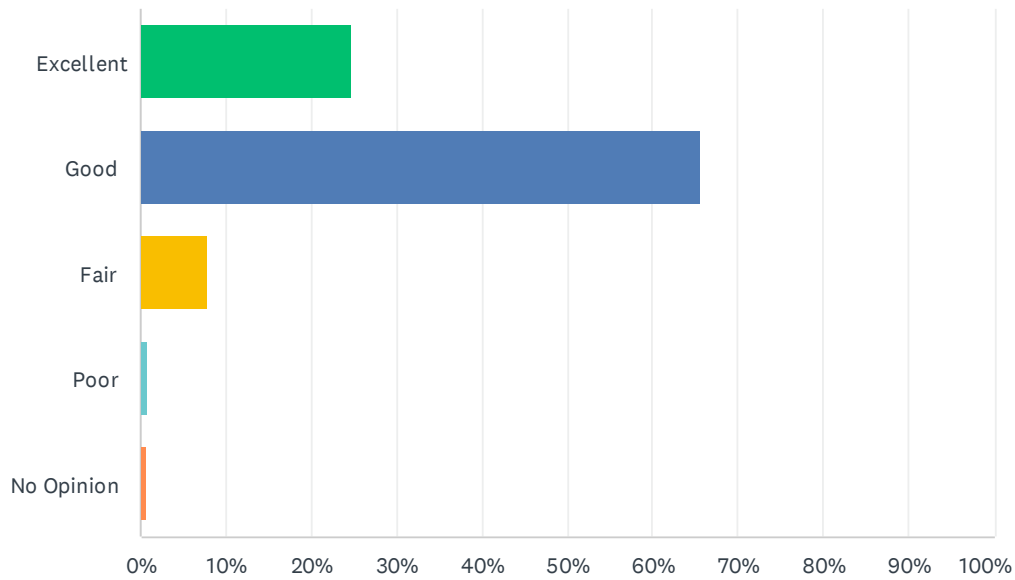

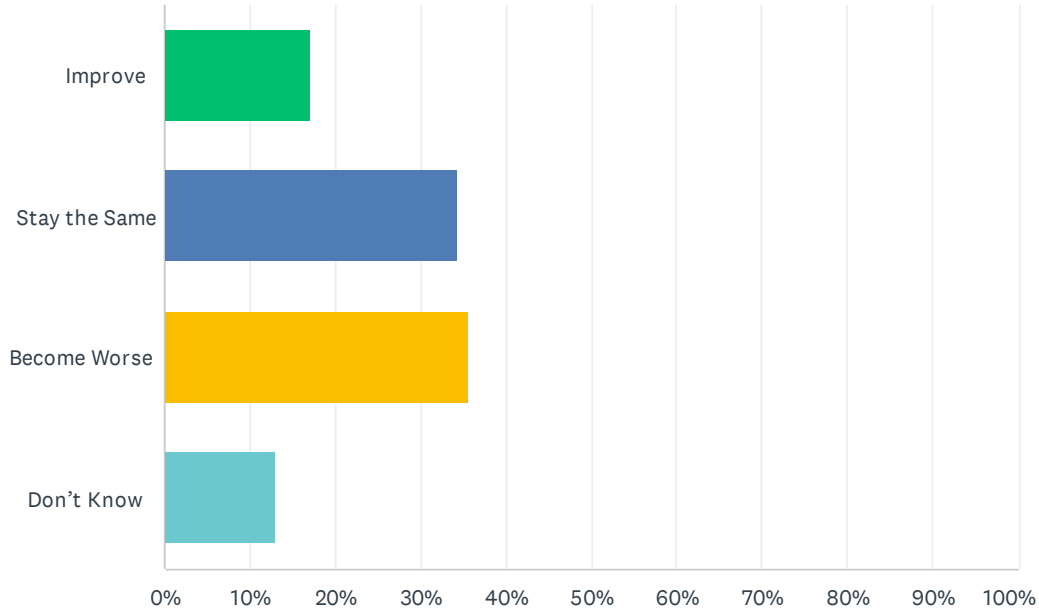

Q3 Over the next 10 years, do you think the quality of life in Town of Richmond will:

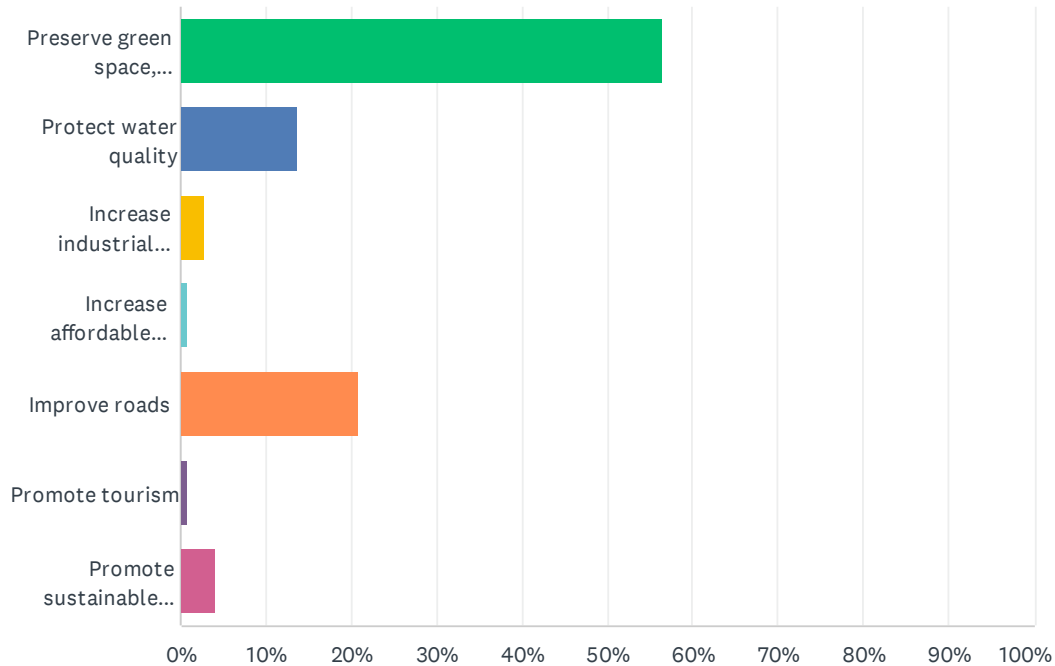

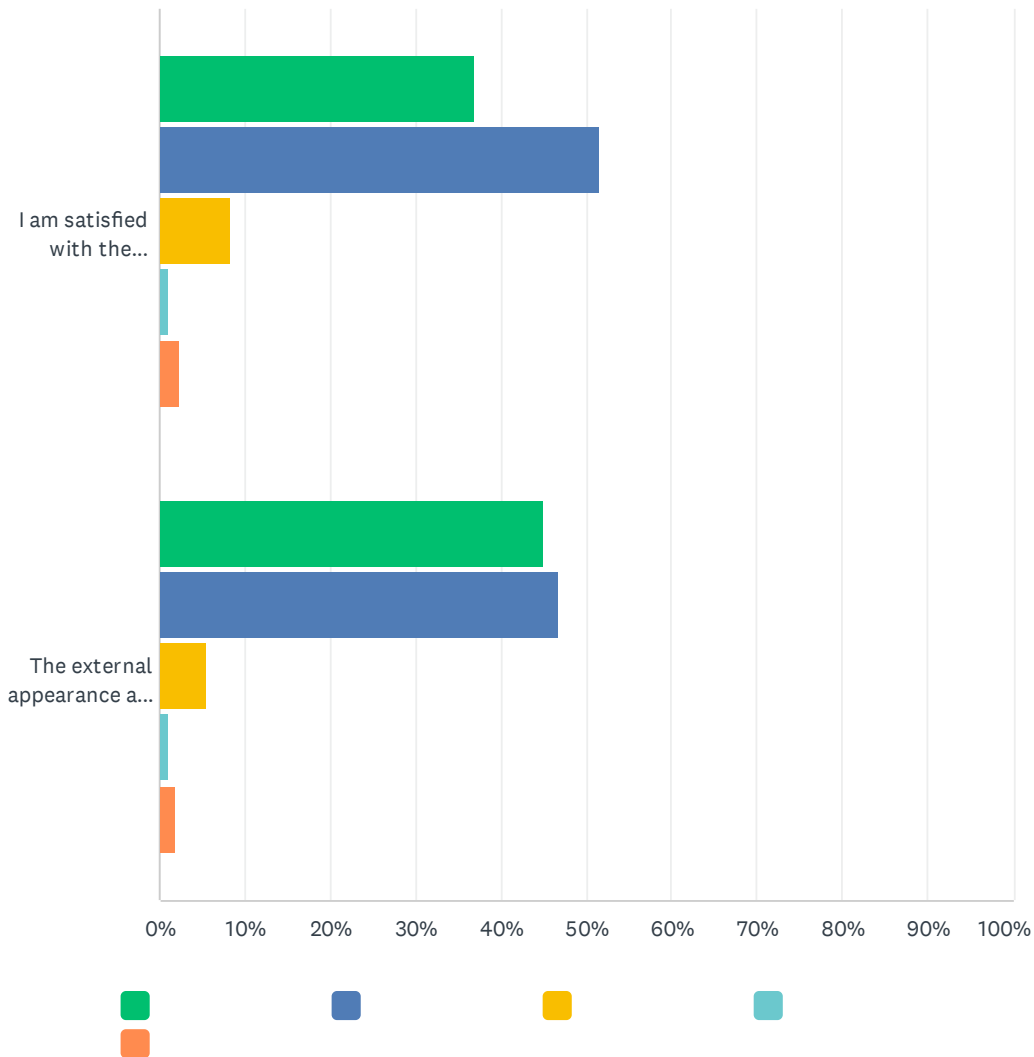

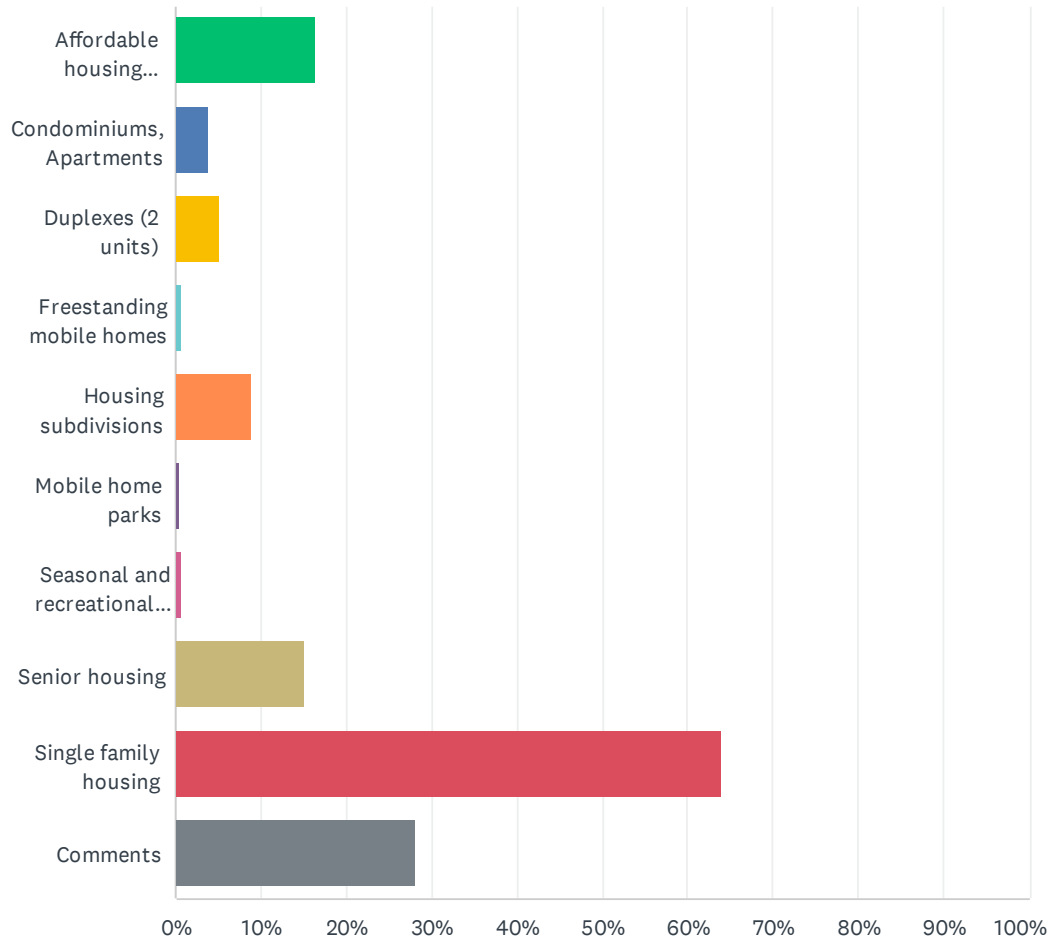

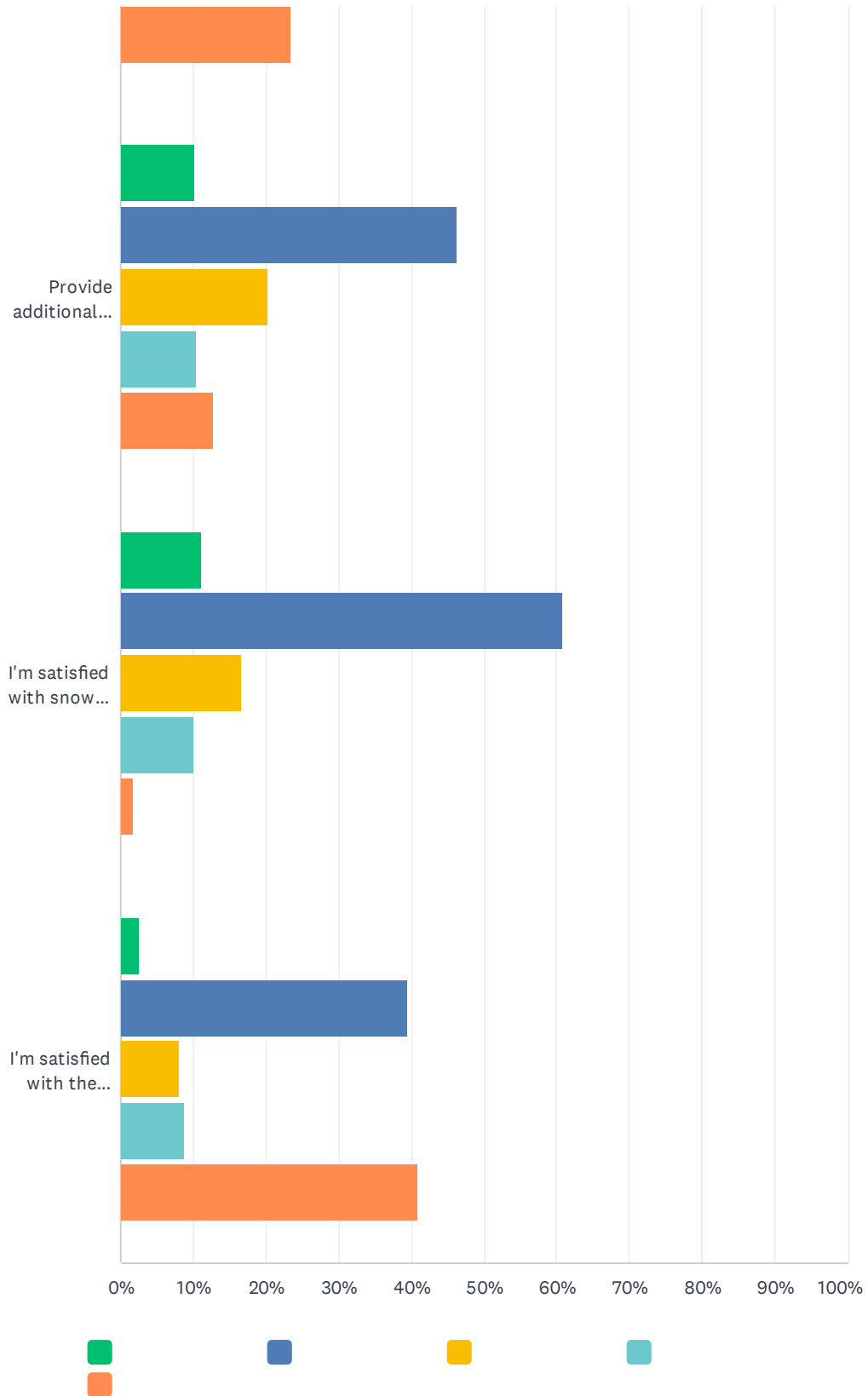

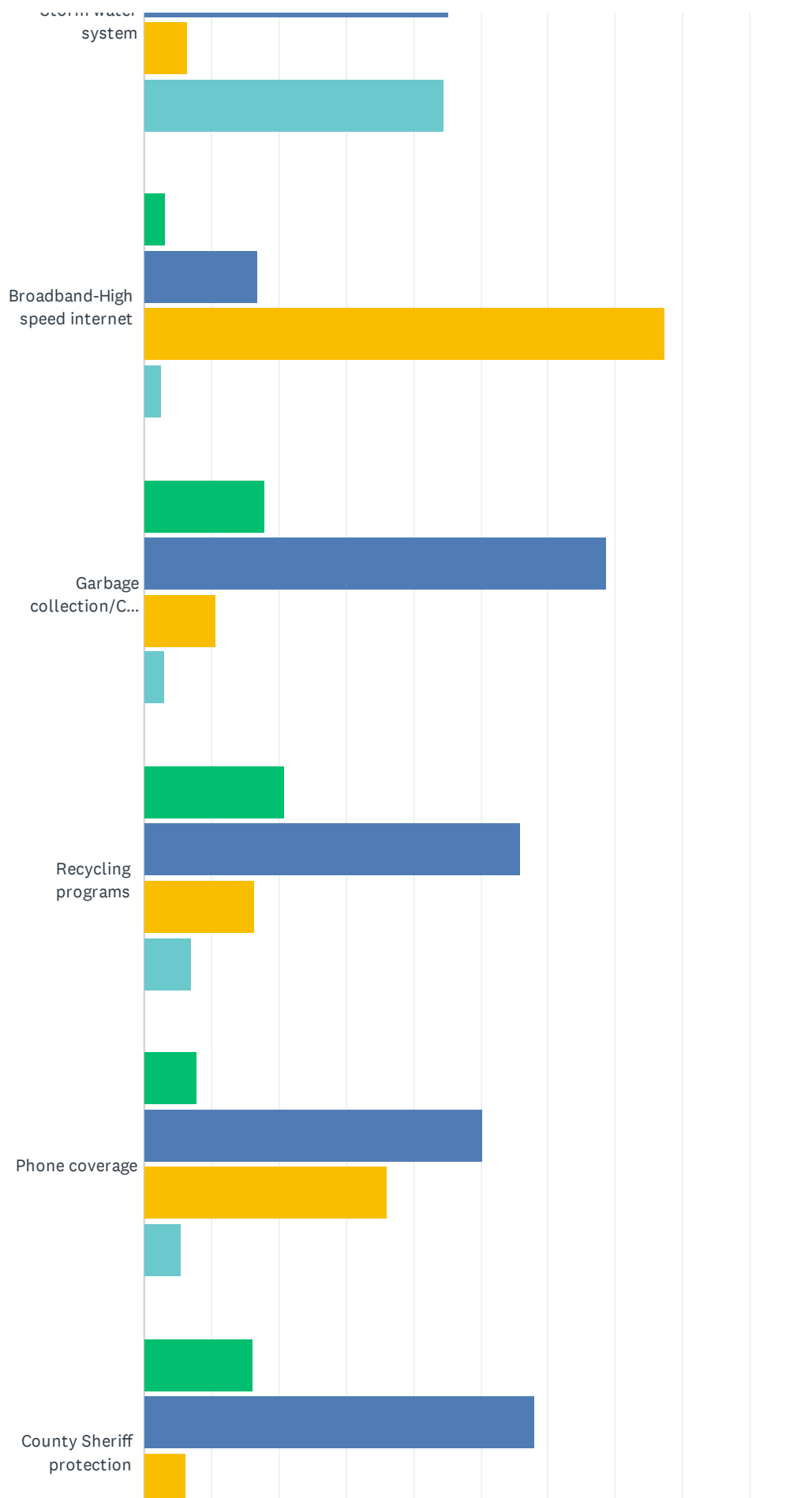


Q9 How would you rate the following existing community facilities, utilities and services in Town of Richmond?

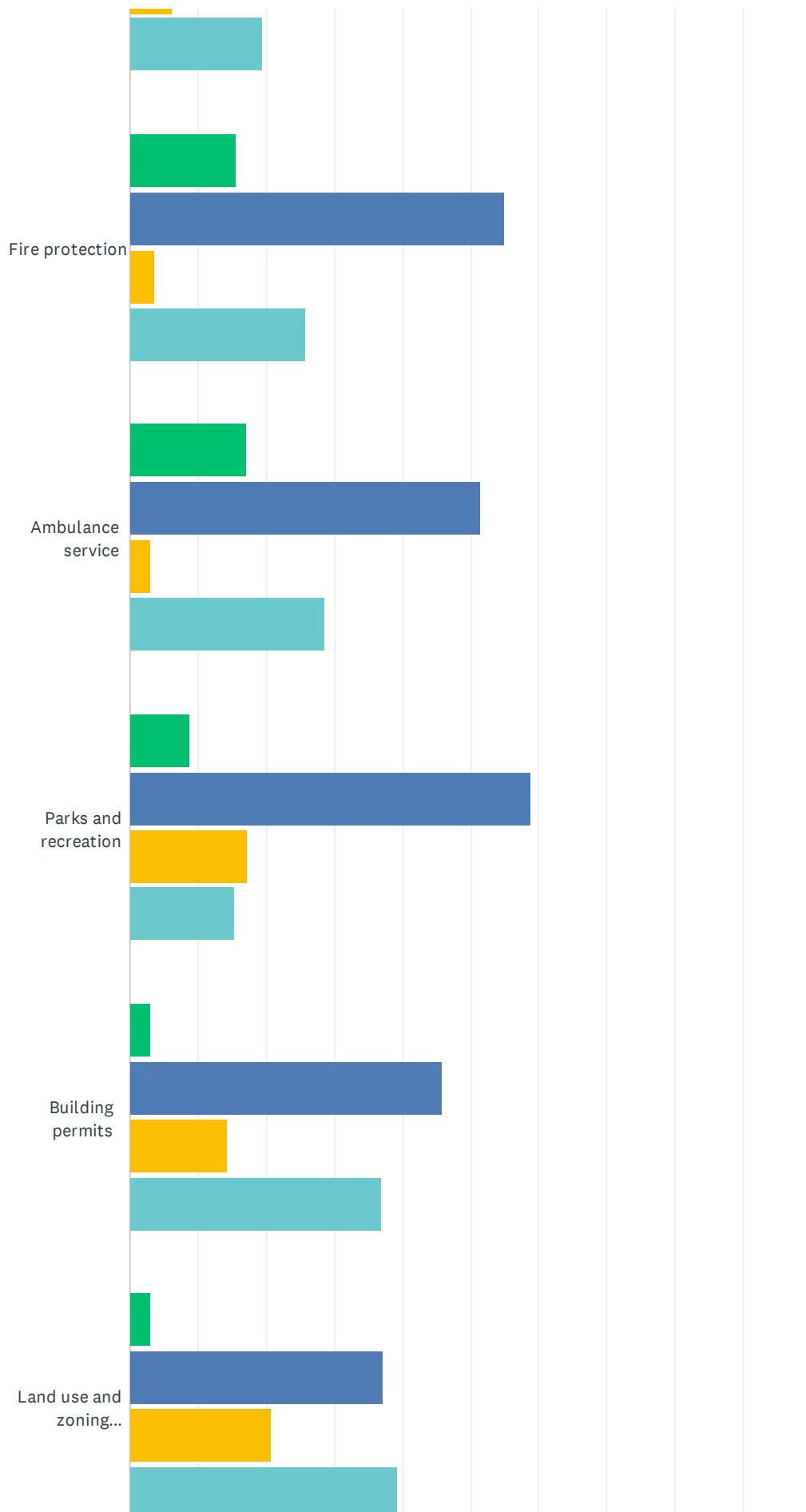

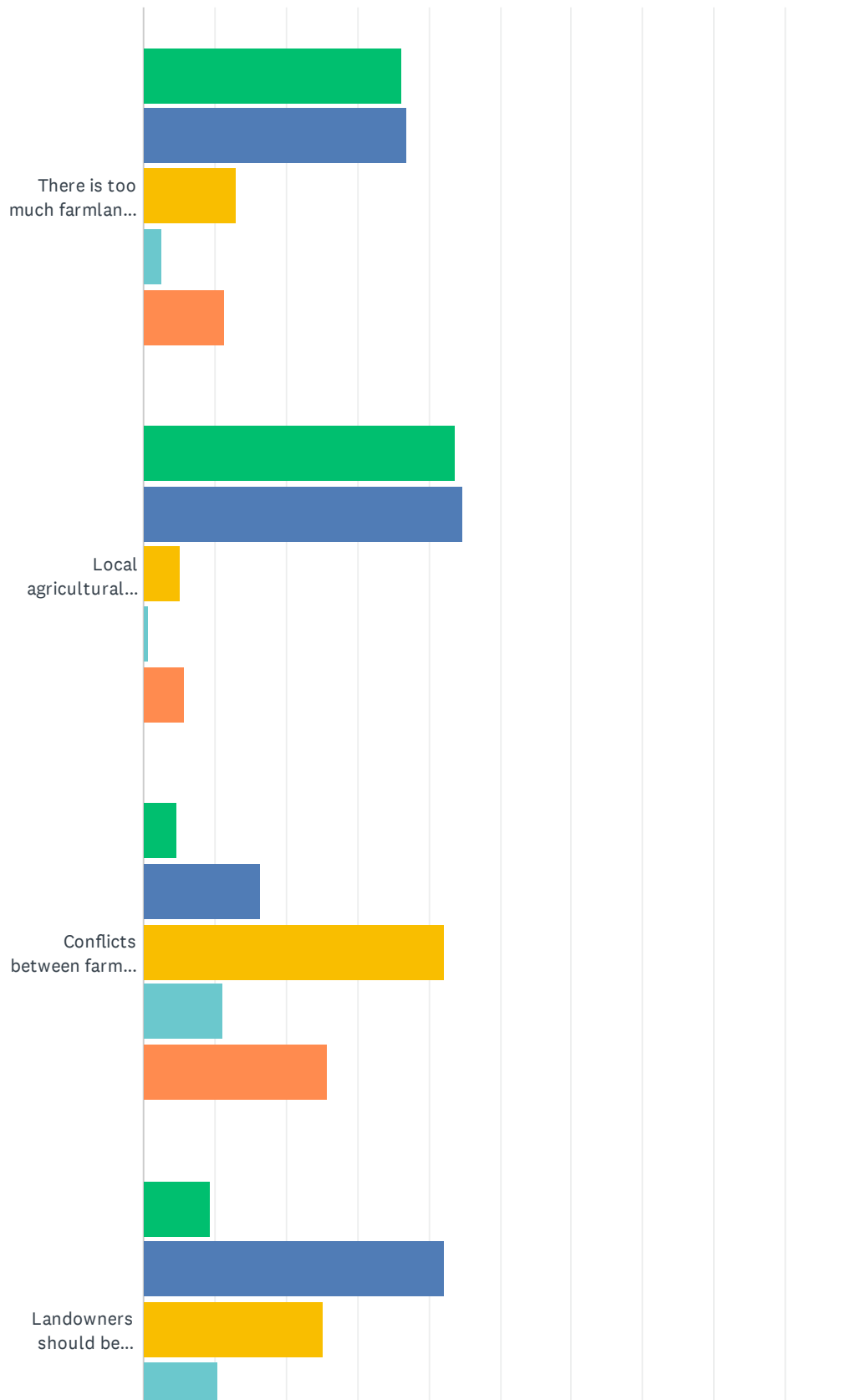

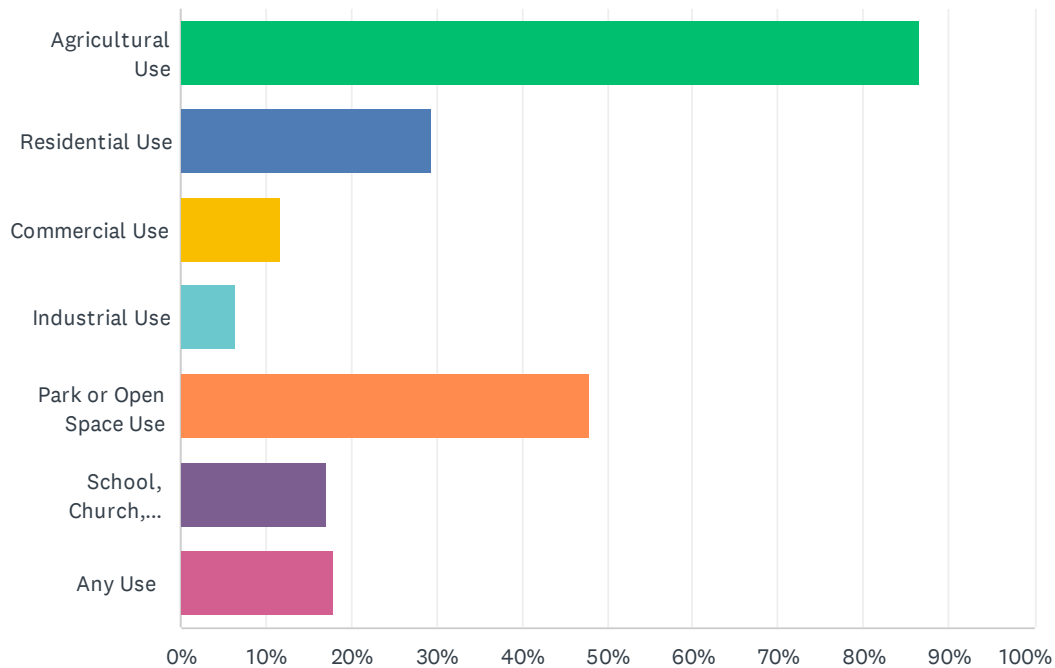

Q13 Agriculture. Productive agricultural land should be allowed to be used for (Check all that apply)

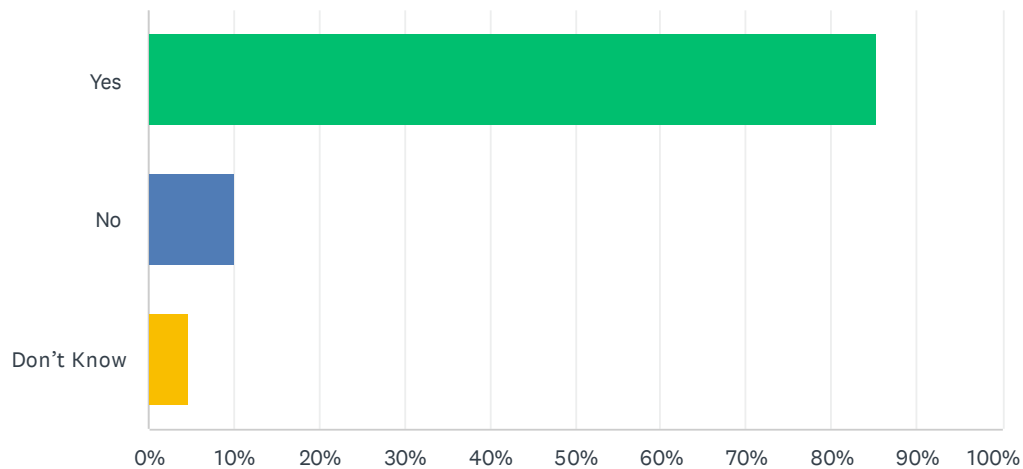

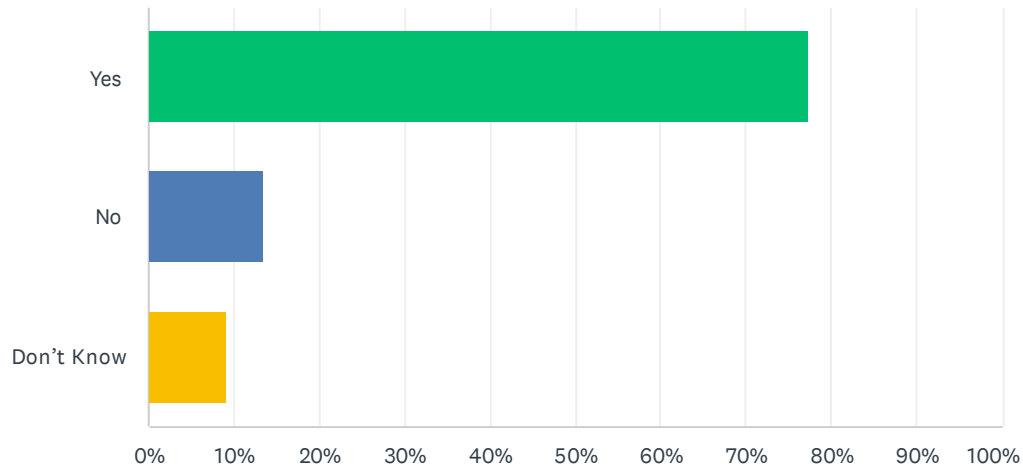

Q19 Should business/commercial developments be restricted to designated areas in the Town of Richmond (rural area outside the city of New Richmond)?

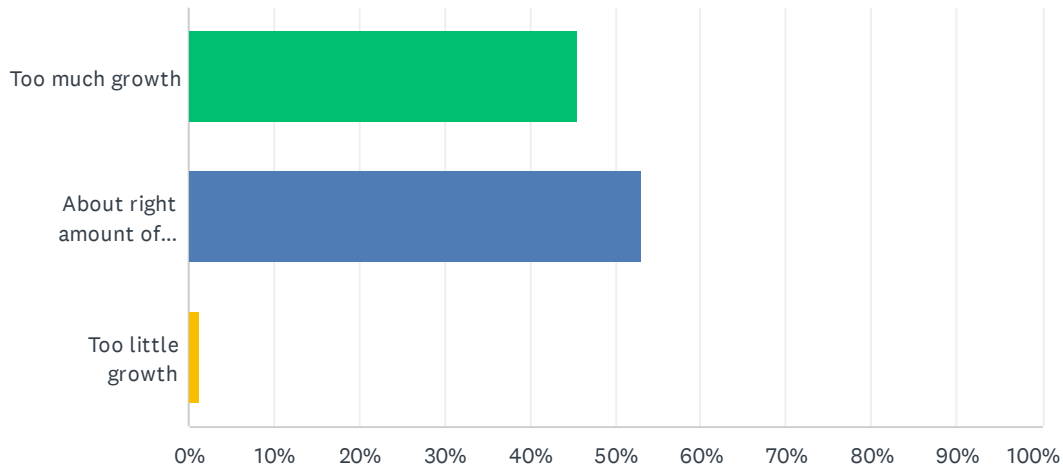

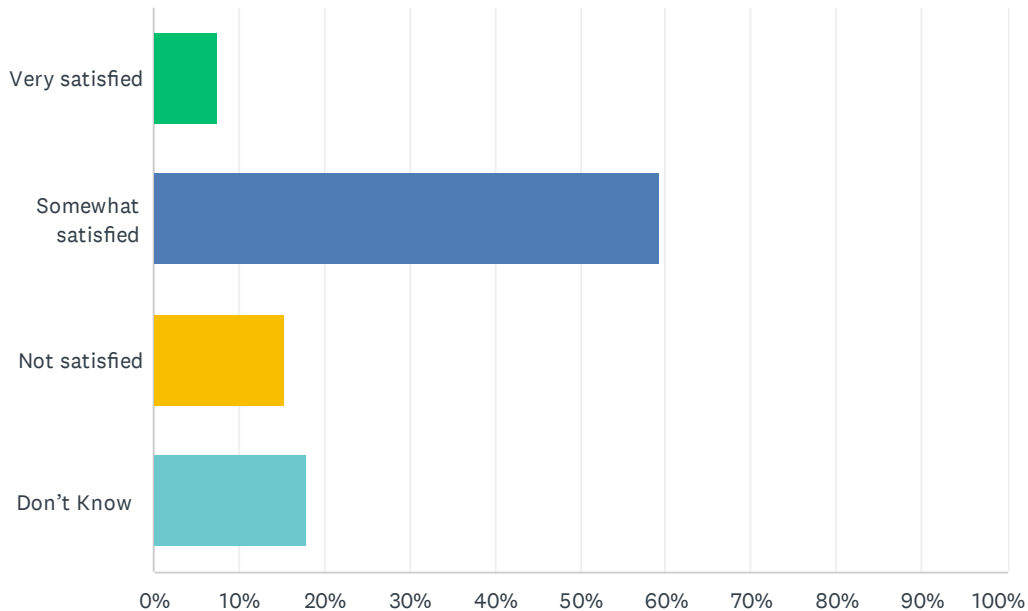

Q21 How satisfied are you with the way the Town of Richmond is developing under the present land use zoning and subdivision ordinances of County and Town?

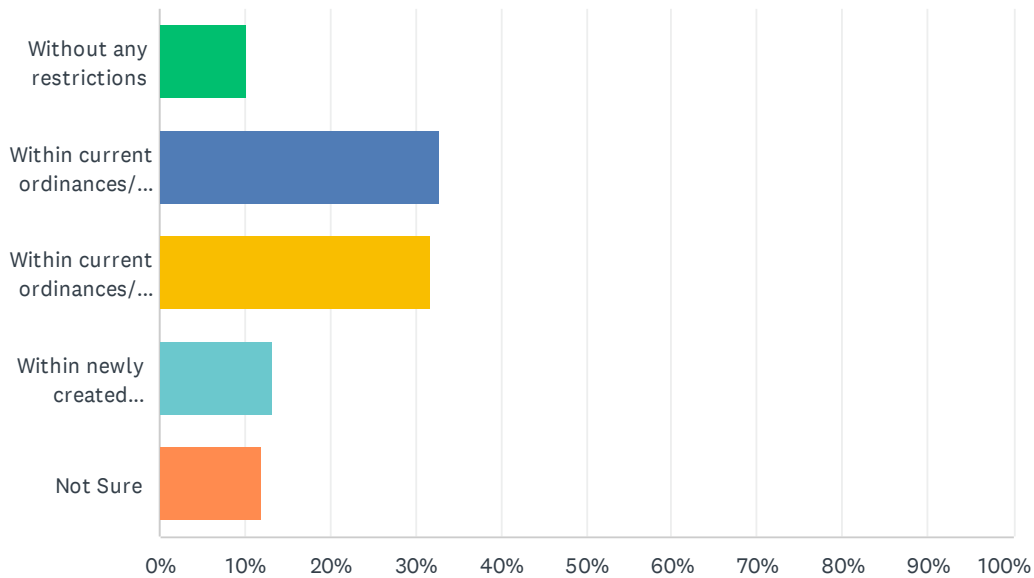

Q22 Land owners should be allowed to develop their land: (Select one)

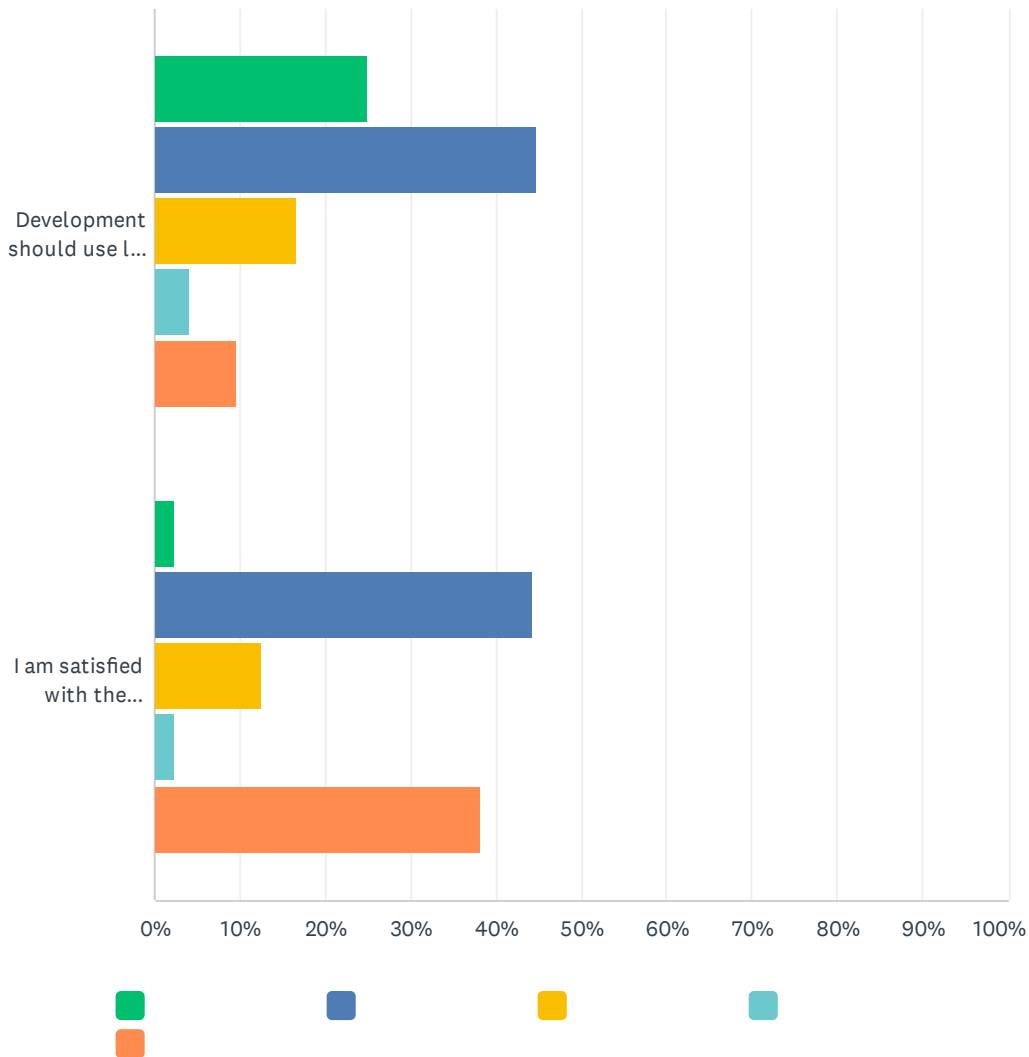

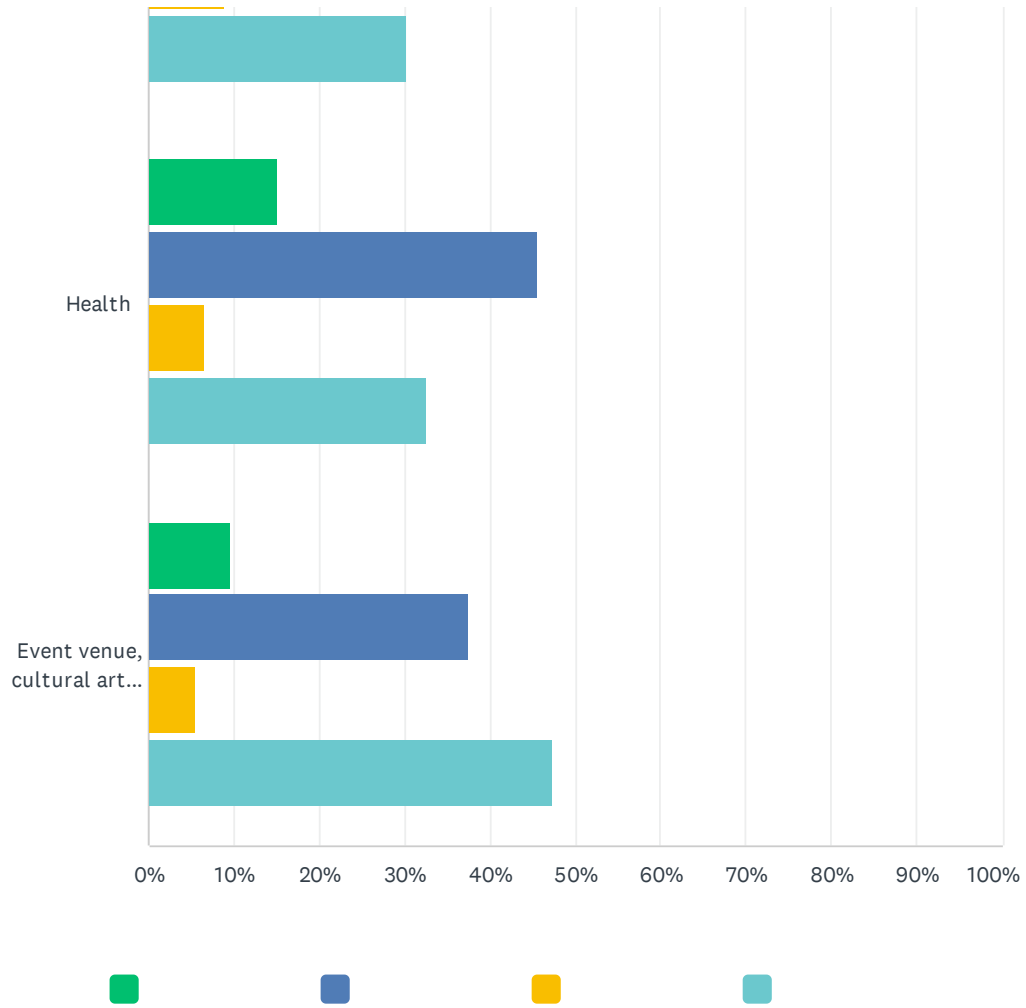

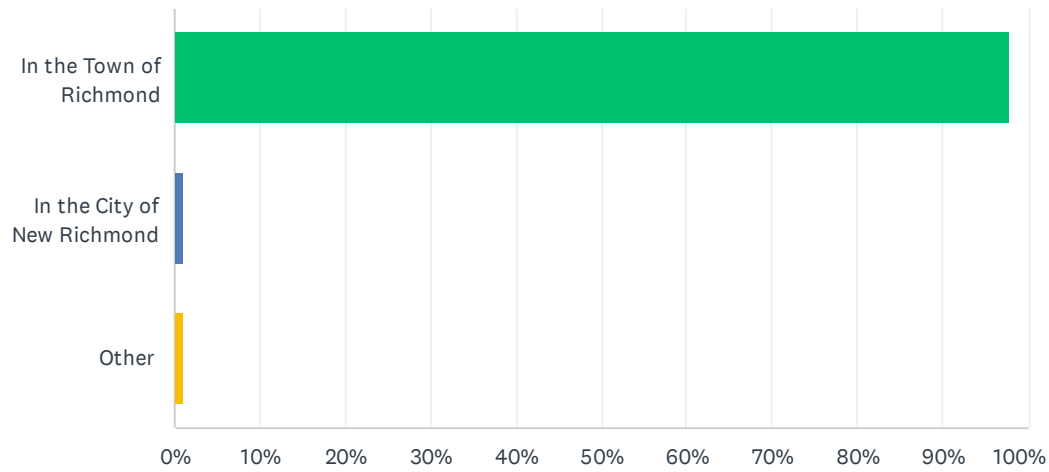

Q28 Where do you live?

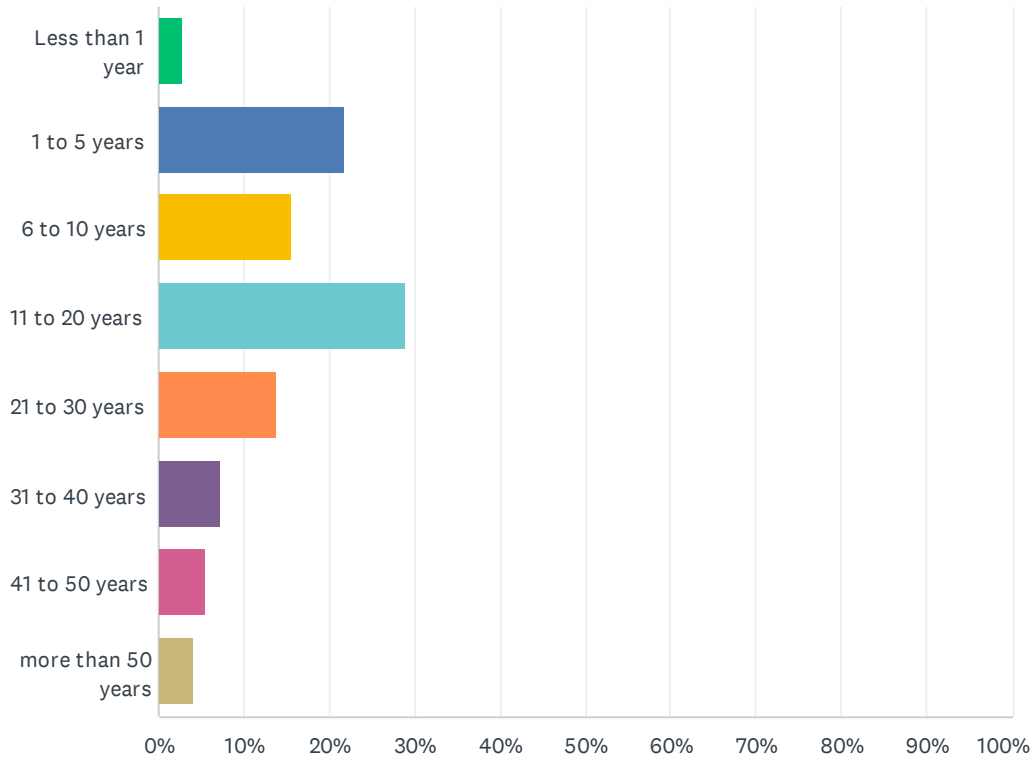

Q29 How long have you lived in the Town of Richmond?

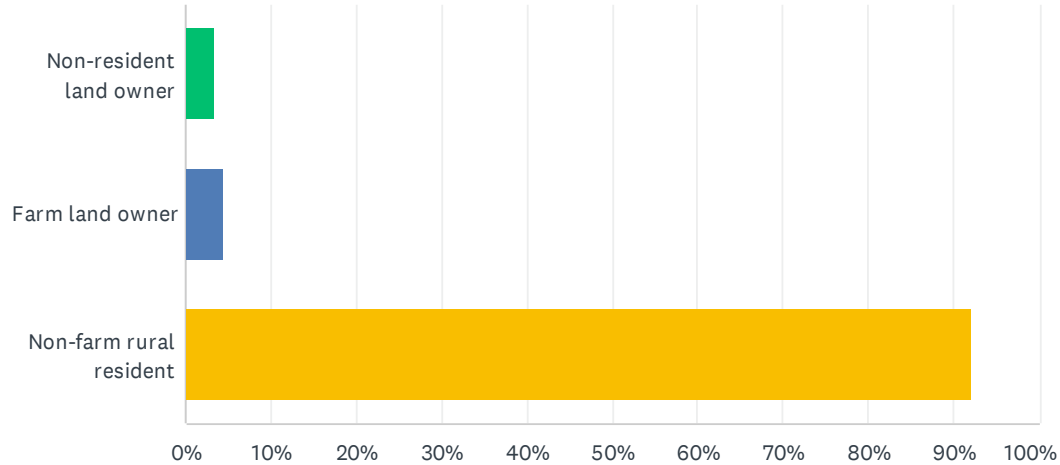
